ADMISSION OF ADDITIONAL MEMBERS

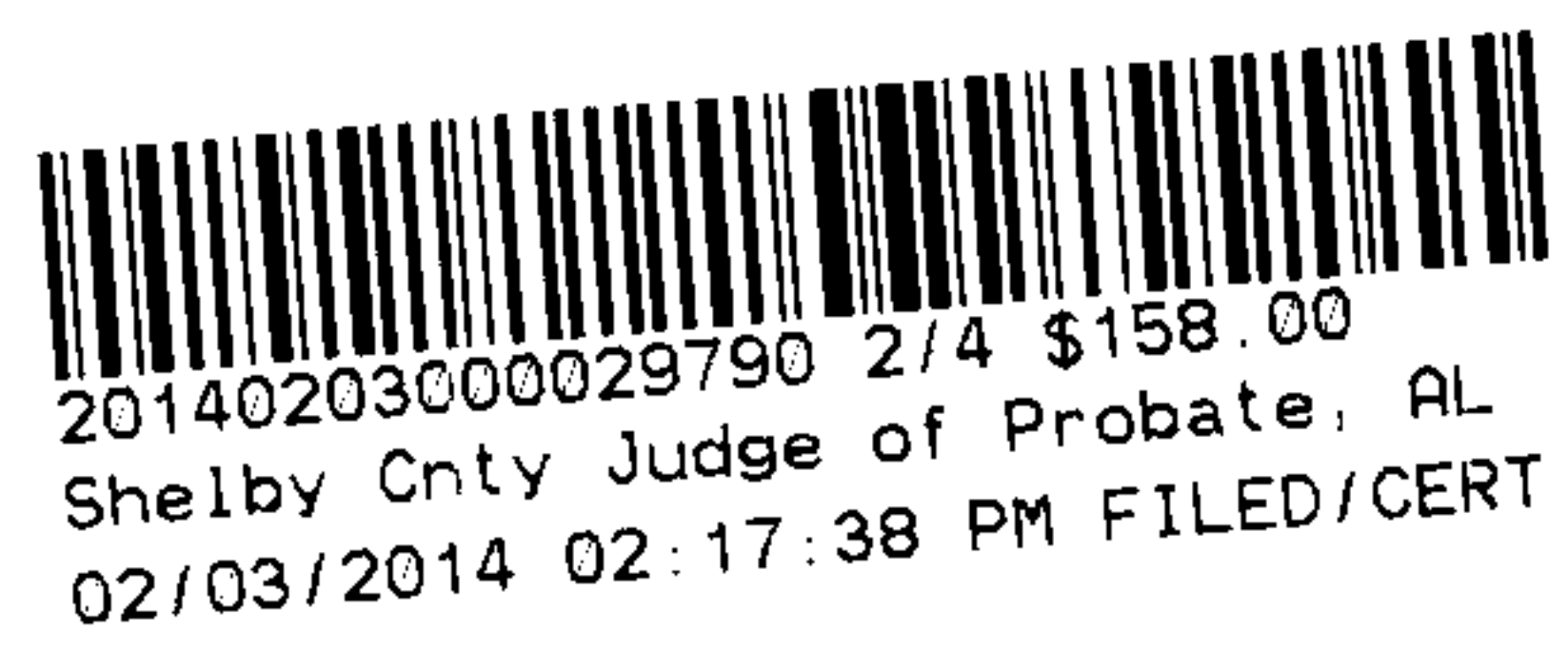
The Members may admit additional members upon such terms and conditions as they may deem appropriate by unanimous agreement in writing.
