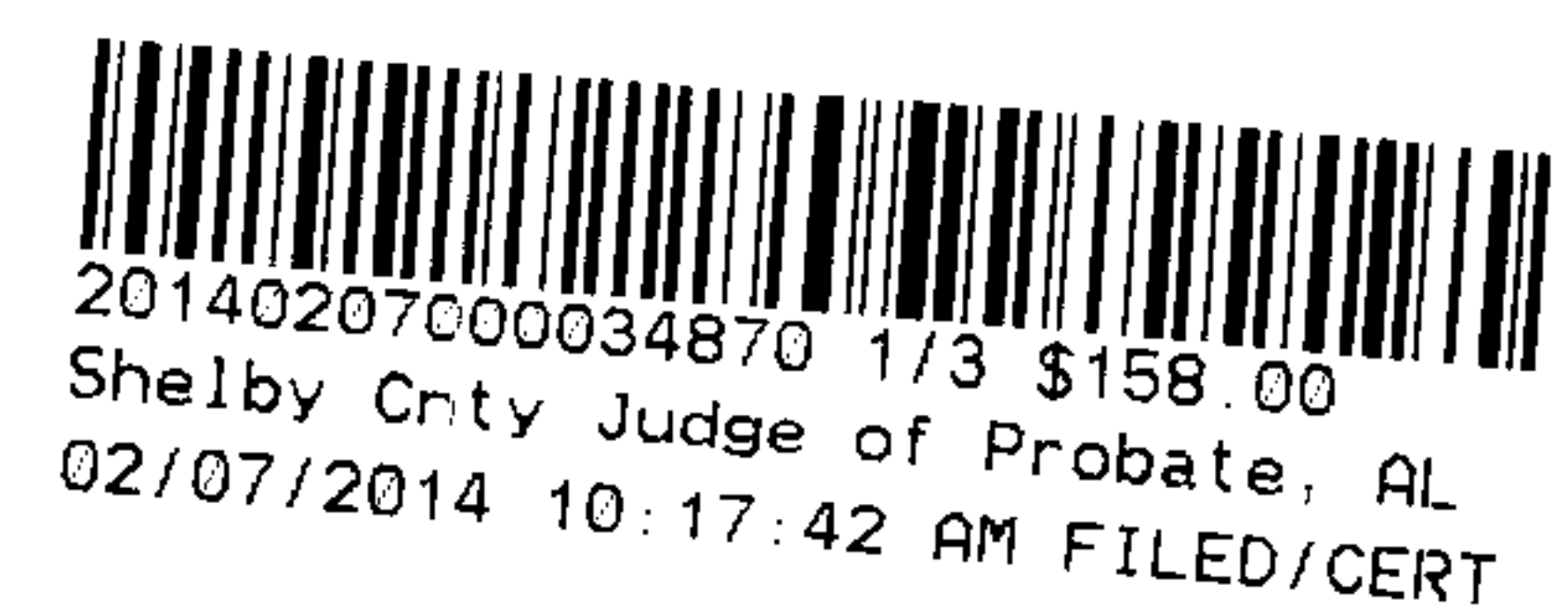

meeting of the members or until their successors are elected and qualified are as follows;






