

FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on October 24, 2008, to-wit: Melvin G. Lee, a single woman, Channel D. Lee, a single woman, and Larry Lee, a single man, executed a mortgage to Mortgage Electronic Registration Systems, Inc. solely as nominee for United Wholesale Mortgage, its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on October 31, 2008, in Instrument Number 20081031000423720, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which said mortgage was subsequently assigned to Ocwen Loan Servicing, LLC, by assignment recorded October 17, 2013, and recorded in Instrument Number 20131017000413330, Probate Records of Shelby County, Alabama; and
