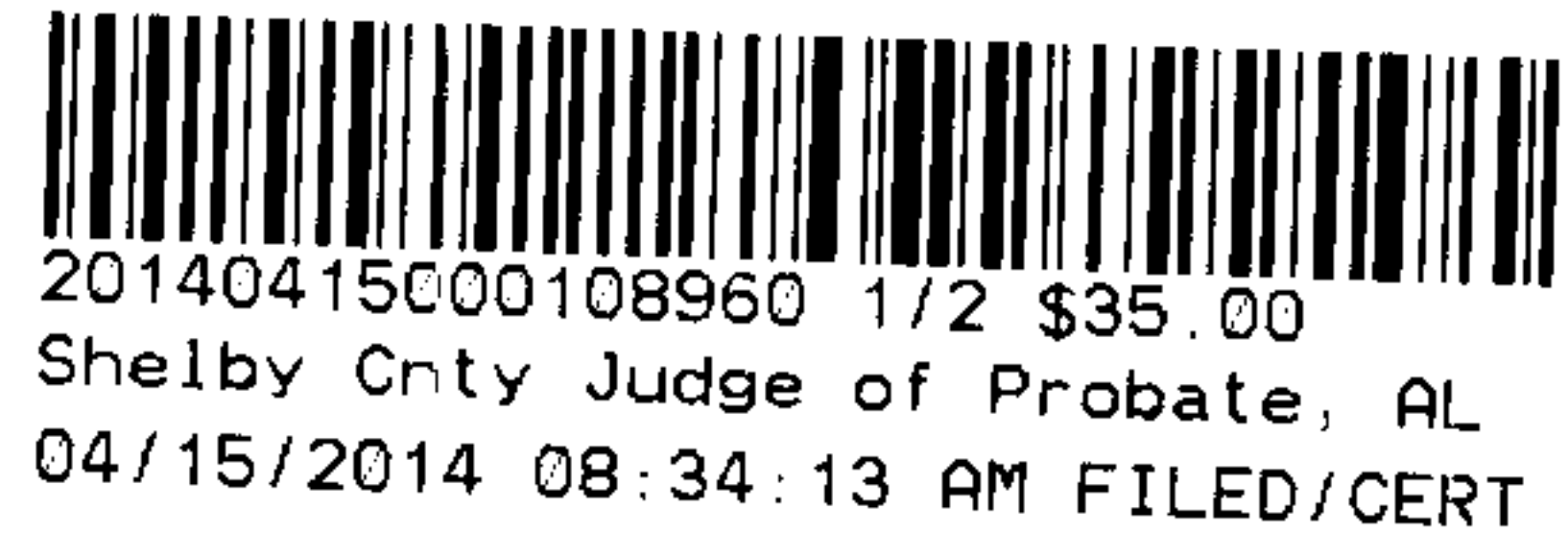


## NOTARY BOND

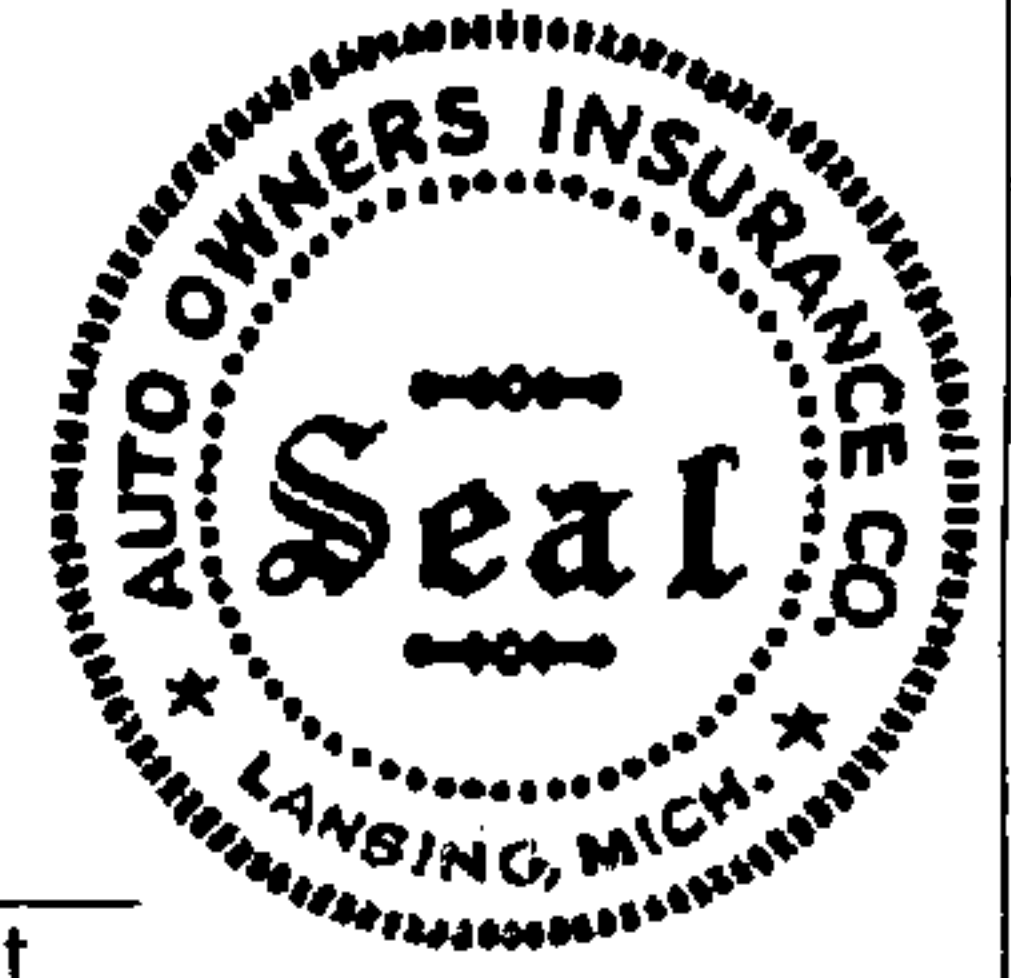

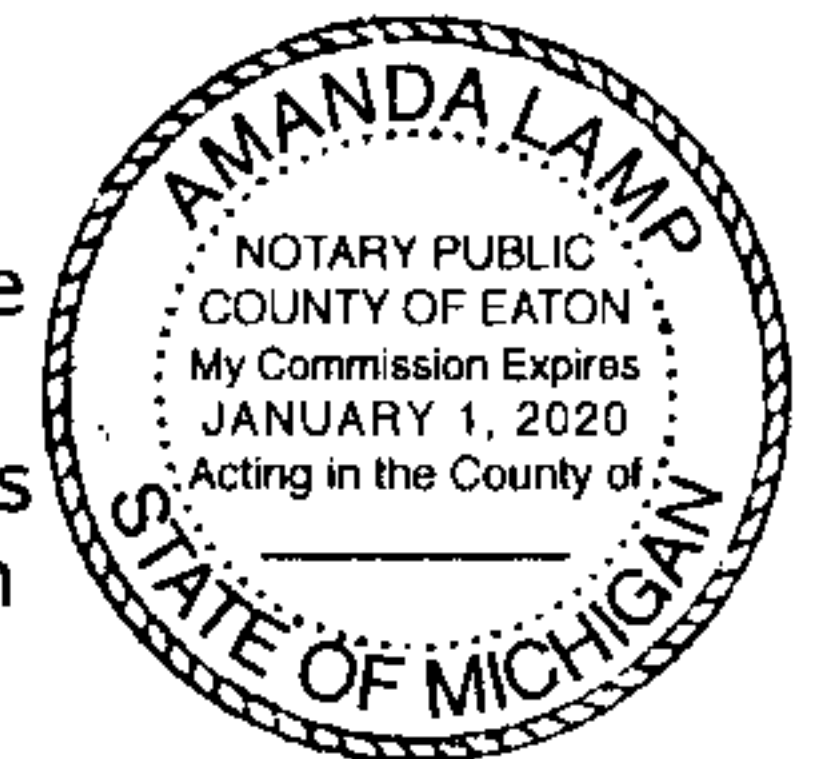


