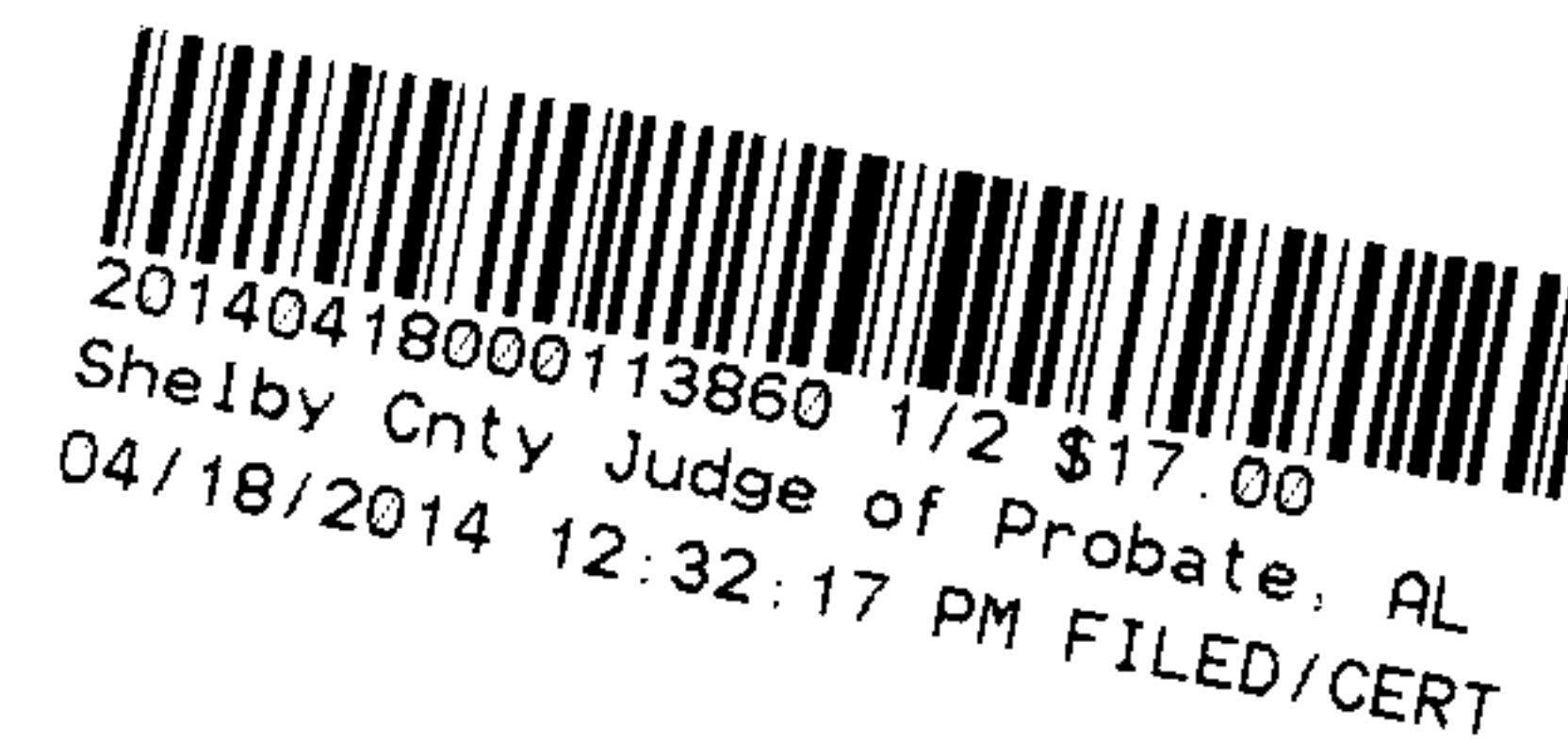

The undersigned Trustors and Trustees hereby certify the following:



All persons relying on this document regarding the Trustees and their powers over trust property shall be held harmless for any resulting loss or liability from such reliance. A copy of this Affidavit of Trust shall be just as valid as the original.
10. The trust is valid and the same person is not the sole trustee and the sole beneficiary. The Trust has a definite beneficiary.

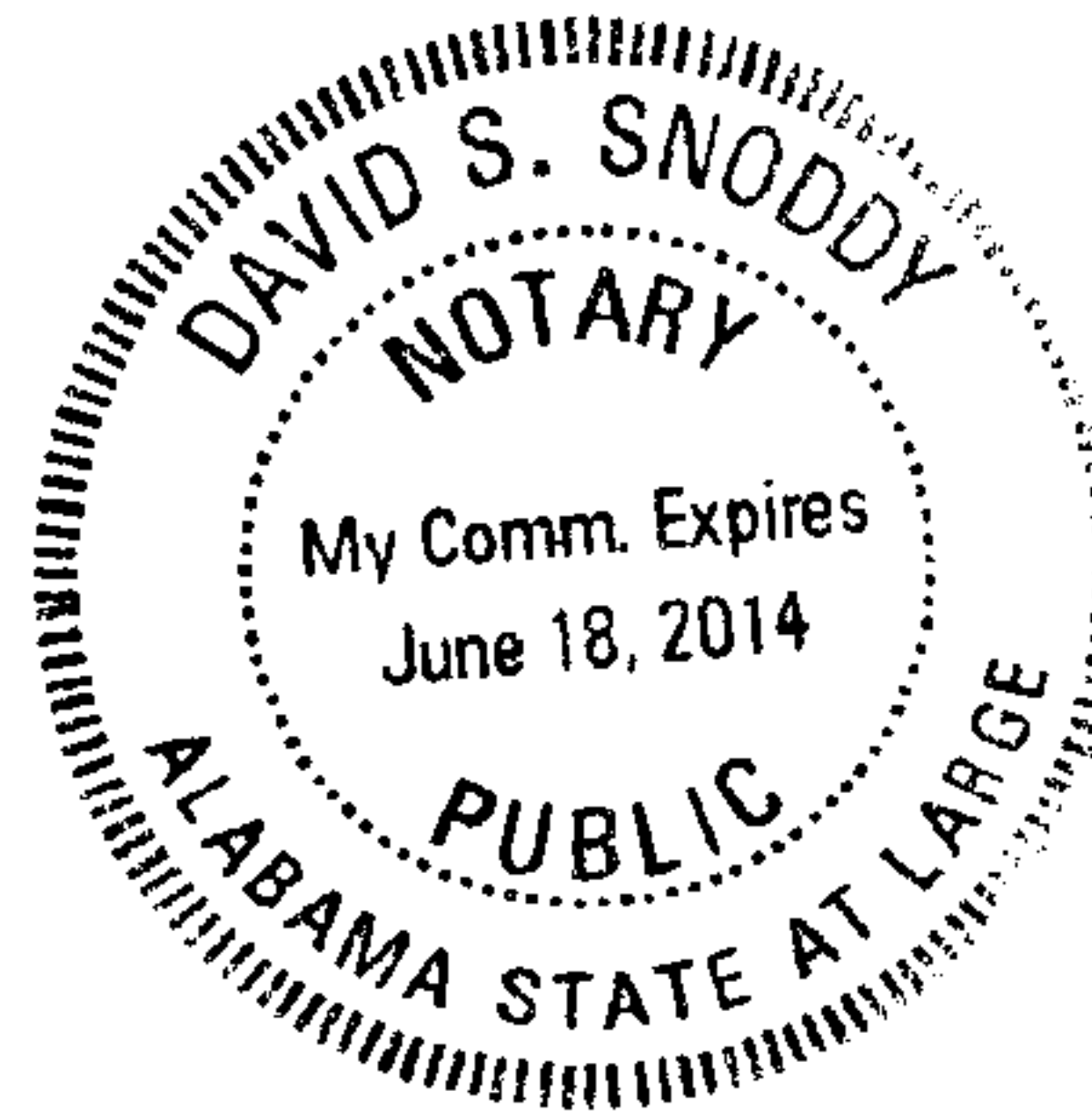
