KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 22nd day of November, 2005, Ted C. Hipp and Janet A. Hipp, husband and wife, executed that certain mortgage on real property hereinafter described to Wells Fargo Bank, N.A., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20051201000622400, said mortgage having subsequently been transferred and assigned to U.S. Bank National Association, as Trustee for Banc of America Funding Corporation, Mortgage Pass-through Certificates, Series 2006-G, by instrument recorded in Instrument Number 20120518000177590, in the aforesaid Probate Office ("Transferee"); and




