
The entire purchase price recited above is being paid by a mortgage closed simultaneously herewith.


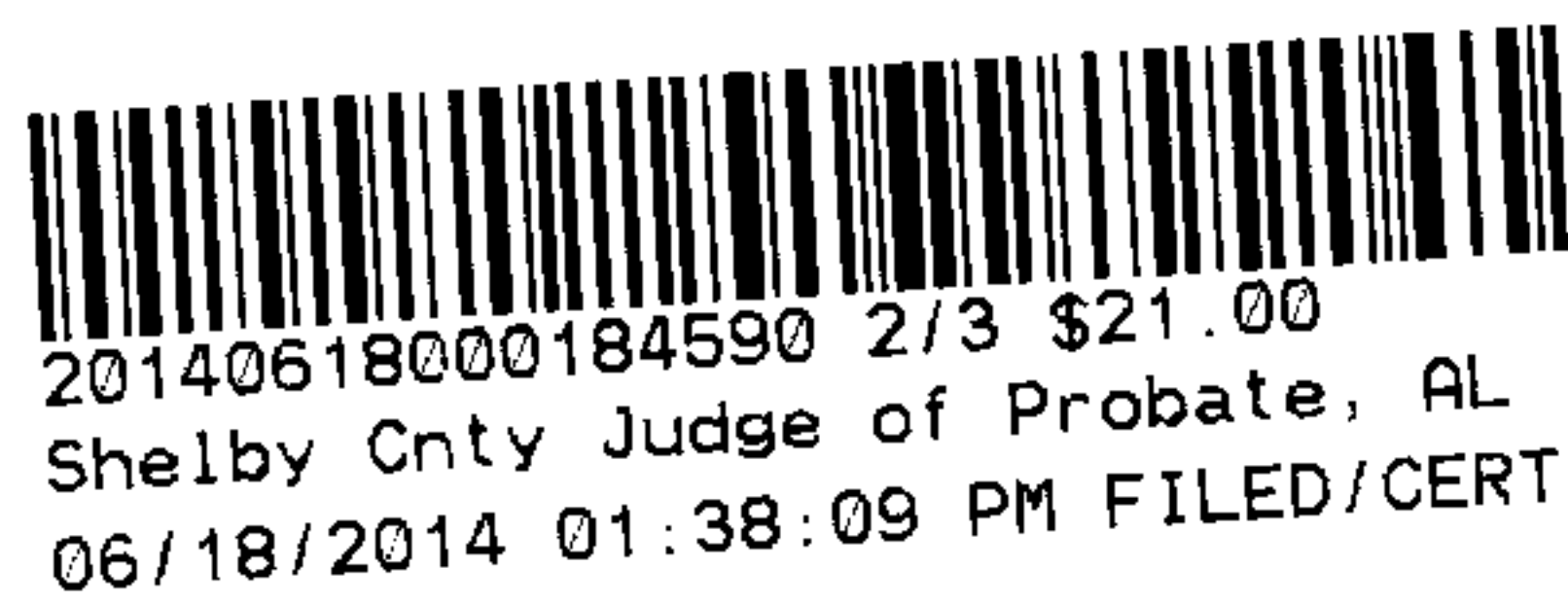

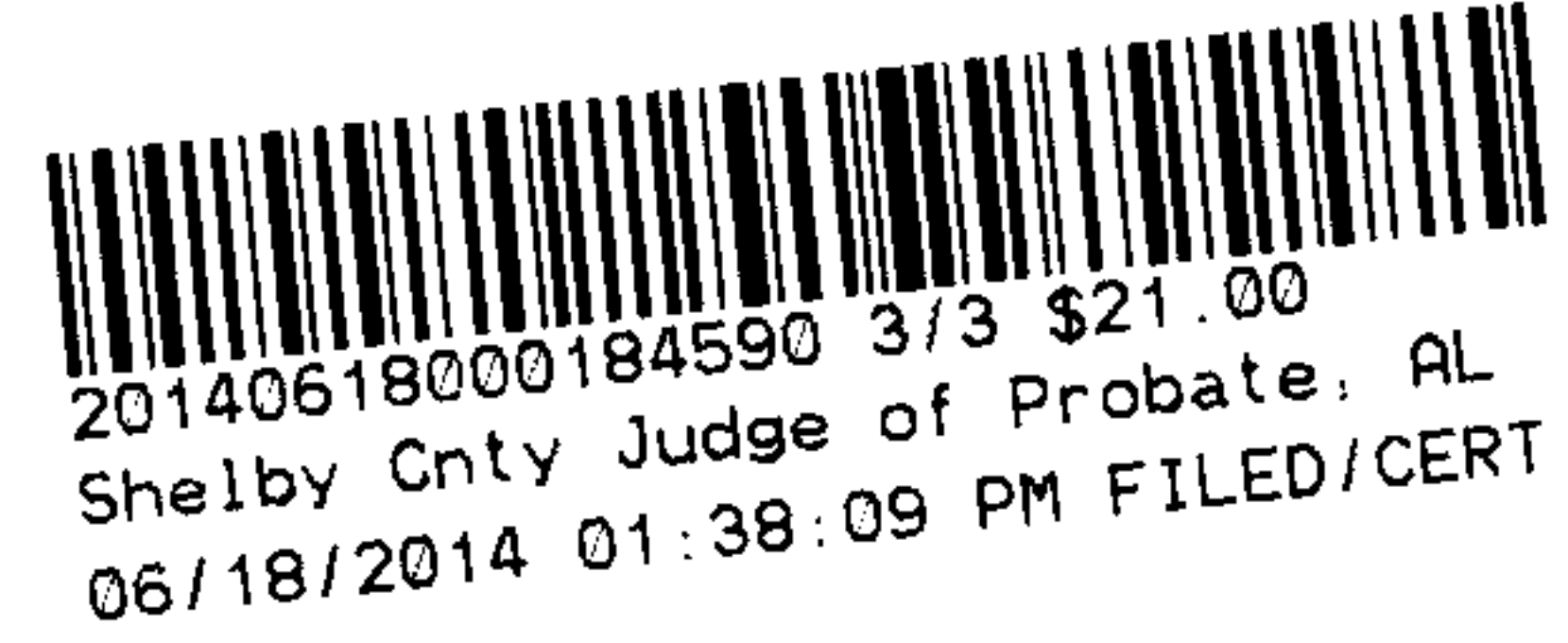
