WITH REMAINDER TO SURVIVOR

Know all Men by these Presents: That, in consideration of Two Hundred Nine Thousand Nine Hundred and No/100ths Dollars (\$209,900.00) and other good and valuable consideration to them in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, **WILLIAM M. BOWEN AND MICHELLE E. BOWEN, Husband and Wife** (herein referred to as "Grantors") do by these presents grant, bargain, sell and convey unto **JOSEPH HOLLOMAN AND DOROTHY HOLLOMAN** (herein referred to as "Grantees") for and during their joint lives and, upon the death of either of them, then to the survivor, in fee simple, and to the heirs and assigns of such survivor forever, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama, to-wit:

Lot 2A, according to the Map and Resurvey of Lot 2, Royal Oaks, 4th Sector, Unit 1, as recorded in Map Book 23, page 60, in the Probate Office of Shelby County, Alabama.

This conveyance is subject to subdivision restrictions, utility, drainage and sewer easements, and minimum setback lines, if any, applicable to the aforesaid property appearing of record in the Office of the Judge of Probate of Shelby County, Alabama. This conveyance is also subject to any prior reservation, severance or conveyance of minerals or mineral rights, taxes and assessments for the year 2014 and all subsequent years, and the following:


1. **Building Setback line of 75 feet reserved from unnamed street, as shown per plat.**

4. **Title to all minerals within and underlying the premises, together with all mining rights and other rights, privileges and immunities relating thereto, including rights set out in Book 31, page 432, in Probate Office.**
5. **Right(s) of Way(s) granted to Alabama Power Company and South Central Bell Telephone Company, as set out in Book 64, page 986, in the Probate Office.**
6. **Right(s)-of-Way(s) granted to South Central Bell Telephone Company, as set out in Book 98, page 103, in the Probate Office.**

\$ 150,000.00 of the consideration herein was derived from a mortgage loan closed simultaneously herewith.





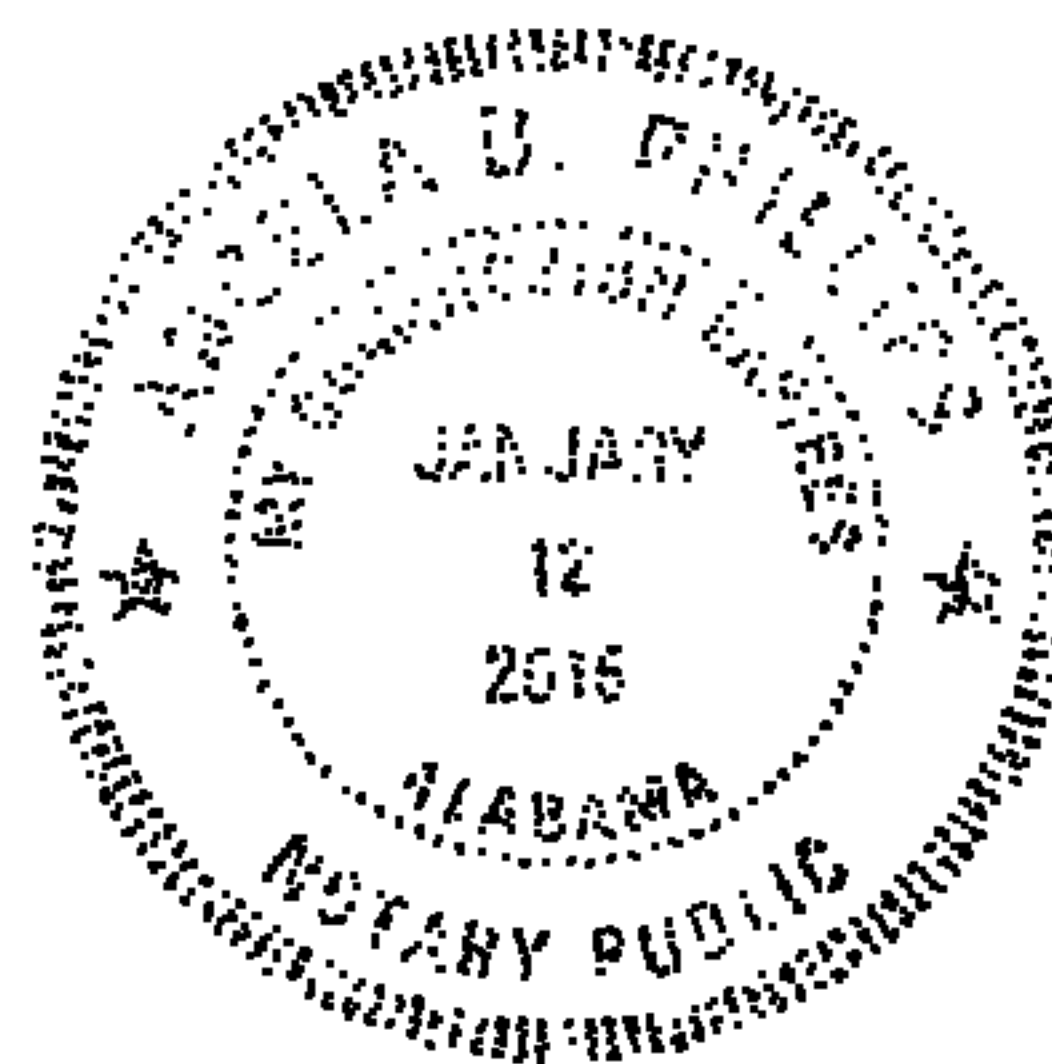
