\$176,248.00 of the purchase price is being paid with a purchase money mortgage being recorded simultaneously herewith.


Subject to rights-of-way, covenants, restrictions, easements, agreements, setback lines, mineral/mining rights, and declarations of record, if any.

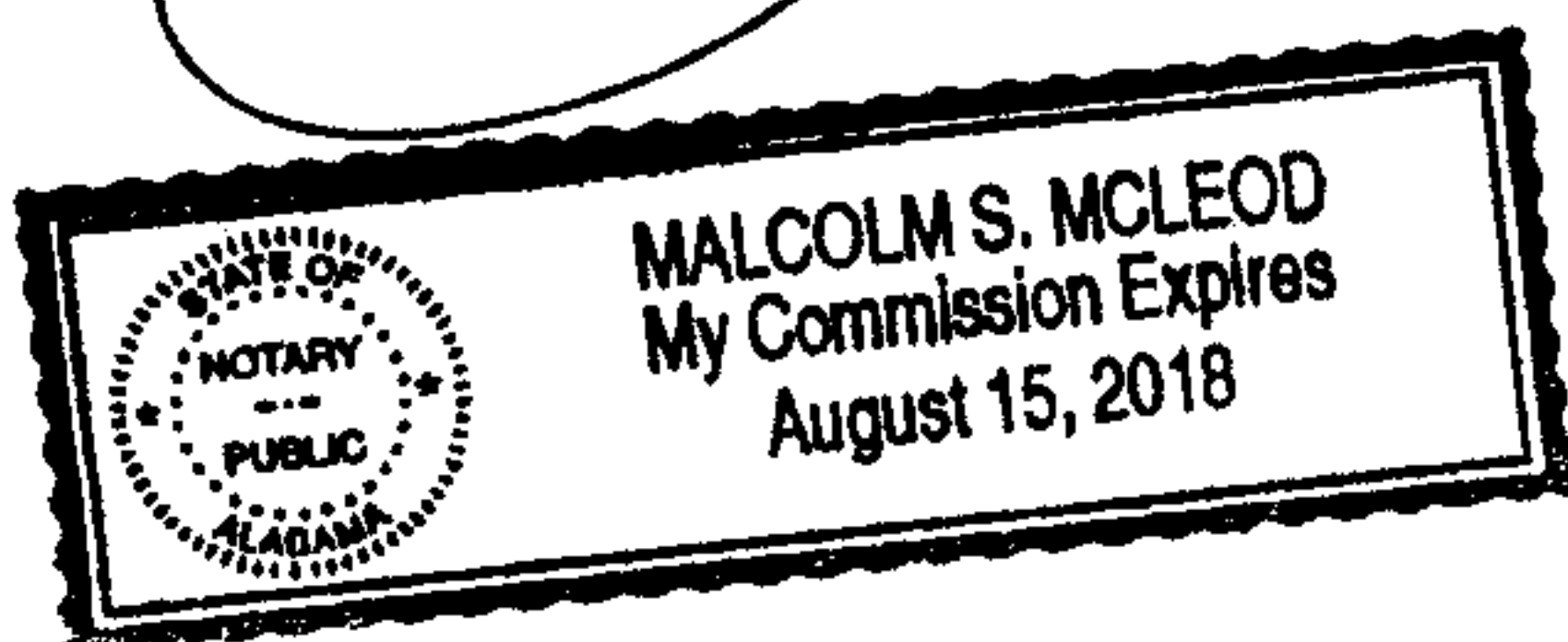
