

Petition & Request for Law Enforcement of Speeding and Traffic Violations in the Saddle Lake Farms Community

We, the undersigned Directors of the Board of Saddle Lake Farms Association, Inc. (the homeowners' association of the Saddle Lake Farms community), do hereby petition and request for traffic control and enforcement in the Saddle Lake Farms community as specified below:

Whereas: We, as the Saddle Lake Farms Board, are encouraged to protect the safety of the residents, pets, and property of our community, and feel the obligation to take appropriate measures in this regard. Reckless driving, speeding, and the running of stop signs cause accidents and sometimes death. We encourage our local law enforcement to accept our request based on the State of Alabama Legislative Act# ACT 2008-401. We encourage law enforcement officers to cite individuals traveling in excess of 10 mph over the posted 25 mph speed limit and to cite individuals not stopping at stop signs. We also encourage the stopping of suspicious four wheelers and other all terrain vehicles traveling late in the night and early morning hours and especially erratic driving, as well as citing any reckless driving violators.

Thusly: We ask for our streets to be patrolled by the Alabaster Police Department and for them to cite speeding, stop sign violations, and reckless driving just as they would in other communities.

And Thusly: We, The Board of Directors of Saddle Lake Farms Association, Inc., are proposing the Probate Judge to accept our letter of resolution based on Act# 2008-401 as we wish to have the safety on our streets maintained. The resolution is "SLFAI Board Resolution" 201408/11A" (of more simply designated as BR-20140811A), was passed at our August 2014 Board Meeting, and the excerpt from the Board Meeting minutes (relating to this resolution) is enclosed.

1. New Business

- a. Numbering System for motions BR-20080616A
 - i. Voted and passed a new numbering log will be kept for SLFAI resolutions.
 - ii. For each motion that carries (made, seconded, and majority of quorum of board approves), that decision will be known as a Resolution of the Board and will be identified as "SLFAI Board Resolution yyyymmddX" (or just "BR-yyyymmddX"), where "yyyymmdd" is the date (the resolution was passed), and "X" is a capital letter, starting with "A".
 - iii. For example, this resolution (to identify resolutions in this manner), is Board Resolution 20080616A, as it was passed on 2008 June 16, and the "A" is because it was the first resolution passed on that date. Thus the next (on same date) will be BR-20080616B.
 - iv. This will serve to aid in referring to and keeping track of board decisions, and built into the naming convention is the date the resolution passed.
- b. AIP (Assessment Incentive plan) BR-20080616B
 - i. Voted and passed This is a plan which gives a credit for the early payment of a unit's annual assessment. Account must be current in order to receive credit. The specifics of the plan can be found by clicking on this <u>AIP Link</u>. This link can also be found on the left-hand panel of the <u>Treasurers Page</u> of our web site, <u>www.SaddleLakeFarms.com</u>
- c. Mileage reimbursement BR-20080616C
 - i. Voted and passed Allows for reimbursement of travel expenses for SLFAI business.
 - ii. Currently allows the standard corporate rate of 50.5¢ per mile.
 - iii. This is in lieu of any other reimbursement
 - 1. Would not be able to also get reimbursed for actual gas purchase, or other costs involved in operating the motor vehicle. This is to compensate for such items.
 - 2. Do not need receipts (as they would not be applicable nor available for such)
 - 3. Must keep careful records, and record all data on "Mileage Allowance" form
 - 4. Attach this form (for Allowance for Mileage) to "Reimbursement Payment" form, and remit to the Treasurer for payment.
 - 5. These forms can be found on the (left-hand panel of the) <u>Treasurers Page</u> (of the www.SaddleLakeFarms.com web site).
- d. Traffic Control BR-20140811A
 - i. **Voted and passed** Authorizes the sending of a letter to the Alabaster Police Chief, requesting their assistance with traffic violation, most notably, speeding, running stop signs, & reckless driving in the neighborhood.
 - ii. Due to recent state legislation, private communities (such as SLF) may now request their City Police Department to patrol and enforce traffic rules, including issuing citations.
