


LAST WILL AND TESTAMENT OF



DAVID W. DENNIS

I, DAVID W. DENNIS, a resident of Shelby County, Alabama, being of sound and disposing mind and memory and over the age of eighteen (18) years and not being actuated by any duress, menace, fraud, mistake, or undue influence, do make, publish, and declare this to be my last Will, hereby expressly revoking all Wills and Codicils previously made by me.

I. MARRIAGE AND CHILDREN

I am married to Ruth L. Dennis, and all references in this Will to my Wife are references to her. I have the following children: Mark Dennis, Michael Dennis, Bryan Dennis and Darla D. Keenan.

- II. EXECUTOR: I appoint Ruth L. Dennis as Executor of this my Last Will and Testament and provide if this Executor is unable or unwilling to serve then I appoint my son, Bryan Dennis and my step-daughter, Dawn Michele Harper-Moustaris, as Co-Executors. My Executor(s) shall be authorized to carry out all provisions of this Will and pay my just debts, obligations and funeral expenses.
- III. SIMULTANEOUS DEATH OF SPOUSE: In the event that my Wife shall die simultaneously with me or there is no direct evidence to establish that my Wife and I died other than simultaneously, I direct that I shall be deemed to have survived my Wife notwithstanding any provision of law to the contrary, and that the provisions of my Will shall be construed on such presumption.
- IV. SIMULTANEOUS DEATH OF BENEFICIARY: If any beneficiary of this Will, including any beneficiary of any trust established by this Will, other than my Wife, shall die within 30 days of my death or prior to the distribution of my estate, I hereby declare that I shall be deemed to have survived such person.

V. BEQUESTS:

- 1. I give, devise, and bequeath all of my estate, of whatever kind and character, and wherever located, to my Wife, provided that my Wife survives me. If my Wife does not survive me, then I direct that my estate shall be divided as follows:
 - A. To my son, Mark Dennis, I bequeath the sum of Fifty (\$50.00) Dollars.
 - B. To my son, Michael Dennis, I bequeath the sum of Fifty (\$50.00) Dollars.
 - C. To my daughter, Darla D. Keenan, I bequeath the sum of Fifty (\$50.00) Dollars.

2. The remainder of my estate, of whatever kind and character, and wherever located, I give, will and bequeath to my step-daughter, Dawn-Michele Harper-Moustaris, absolutely and in fee simple. If my step-daughter shall predecease me, then her share will pass to my son, Bryan Dennis. If my son, Bryan Dennis, shall predecease me, then his share will pass, to Nicole B. Keenan and Joshua J. Harper, to share in equal parts, absolutely and in fee simple.

If a named beneficiary to this Will predeceases me, the bequest to such person shall lapse, and the property shall pass under the other provisions of this Will. If I do not possess or own any property listed above on the date of my death, the bequest of that property shall lapse.

VI. ALL REMAINING PROPERTY; RESIDUARY CLAUSE: I give, devise, and bequeath all of the rest, residue, and remainder of my estate, of whatever kind and character, and wherever located, to my Husband, provided that my Husband survives me. If my Husband does not survive me, then I give, devise, and bequeath all of the rest, residue, and remainder of my estate, of whatever kind and character, and wherever located, to my step-daughter, Dawn Michele Harper-Moustaris and my son, Bryan Dennis, to share in equal parts, absolutely and in fee simple. If either my step-daughter or my son shall predecease me, then his or her share will pass, per share, to his or her lineal descendants, natural or adopted, if any, who survive me; but if there are none, then his or her share will lapse and pass according to the order of intestate succession in the State of Alabama.

If a named beneficiary to this Will predeceases me, the bequest to such person shall lapse, and the property shall pass under the other provisions of this Will. If I do not possess or own any property listed above on the date of my death, the bequest of that property shall lapse.


- VI. ADDITIONAL POWERS OF THE EXECUTOR: My Executor shall have the following additional powers with respect to my estate, to be exercised from time to time at my Executor's discretion without further license or order of any court.
 - 1. I direct my Executor hereinafter named to pay all my just debts, including my funeral expenses and the expenses of my last illness, as soon after my death as may be practical.

VII. WAIVER OF BOND, INVENTORY, ACCOUNTING, REPORTING AND APPROVAL: My Executor and alternate Executor shall serve without any bond, and I hereby waive the necessity of preparing or filing any inventory, accounting, appraisal, reporting, approvals or final appraisement of my estate. I direct that no expert appraisal be made of my estate unless required by law.

VIII. OPTIONAL PROVISIONS: I have placed my initials next to the provisions below that I adopt as part of this Will. Any unmarked provision is not adopted by me and is not a part of this Will.


If any beneficiary to this Will is indebted to me at the time of my death, and the

	beneficiary evidences this debt by a valid Promissory Note payable to me, then such person's portion of my estate shall be diminished by the amount of such debt.
<u>.</u>	Any and all debts of my estate shall first be paid from my residuary estate. Any debts on any real property bequeathed in this Will shall be assumed by the person to receive such real property and not paid by my Executor.
D(e) ()	I direct that my remains be cremated and that the ashes be disposed of according to the wishes of my Executor.

	I desire to be buried alongside my Wife, Ruth L. Dennis. If my Wife survives me, she shall make all burial arrangements according to her wishes. In the event that my Wife predeceases me, I direct that my Executor bury my remains alongside my Wife, wherever that location may be.
