FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that:

WHEREAS, heretofore, on, to-wit: the 21st day of May, 2009, Carol Horn Shurbet, a single person, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as nominee for Network Funding, L.P., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, as Instrument Number 20090528000202220, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, NA "Transferee"), by instrument executed on March 21, 2014 and recorded on March 28, 2014 in Instrument 20140328000087290, in the aforesaid Probate Office; and
