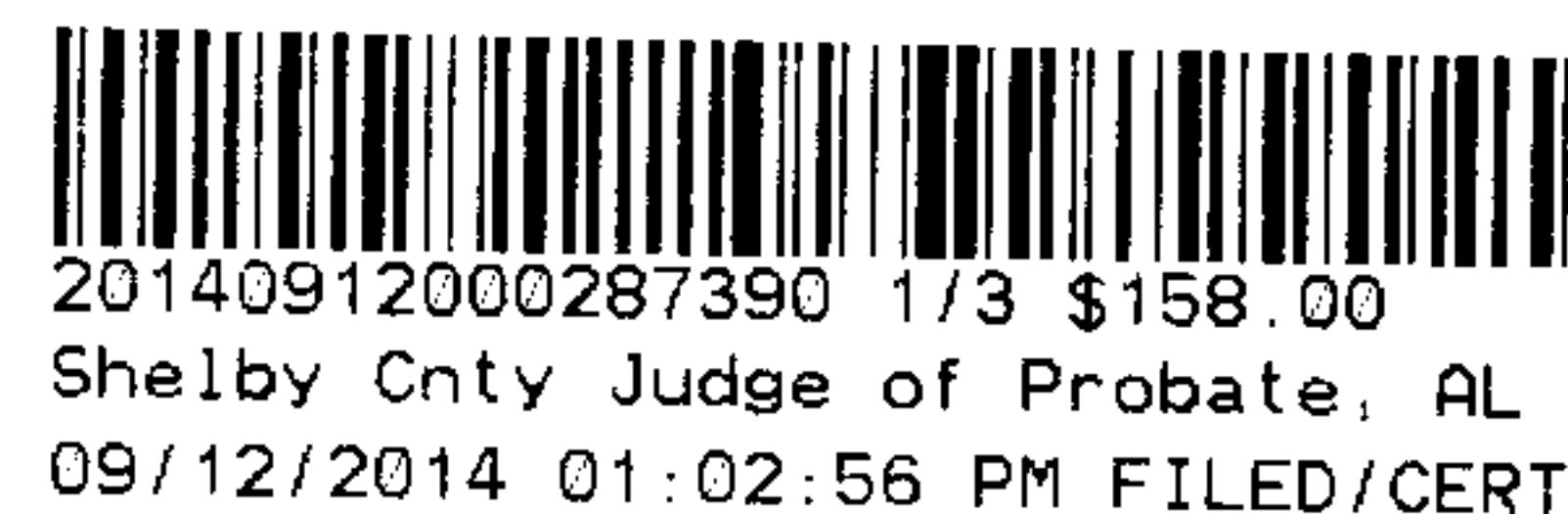


ARTICLES OF ORGANIZATION

OF

WHITE-PECHER PROPERTIES, LLC



1. The name of the limited liability company is White-Pecher Properties, LLC (the "Company").

2. The period of the Company's duration is perpetual.

3. The purpose for which the Company is organized is the transaction of any or all lawful business for which a limited liability company may be organized under the Alabama Limited Liability Company Law, including, but not limited to, the business of owning, managing and maintaining the real estate located at 475 Blue River Drive, Lincoln, Talladega County, Alabama, together with (i) all of the appurtenances, privileges and easements pertaining thereto; (ii) the house and all other improvements located thereon; (iii) the furniture, furnishings and other items of tangible personal property situated therein, and (iv) the boats and other watercraft used in connection therewith.

7. Upon the written consent of a majority of the members, the Company may permit the admission of additional members and the terms and conditions of their admission shall be set forth in the Company's operating agreement.

8. The cessation of membership of one or more members shall not result in the dissolution of the Company.

9. The managers of the Company shall have the power to manage the business and affairs of the Company as provided in the Company's operating agreement. The name and mailing address of the manager of the Company, who shall serve until her successor is elected and begin serving, is: Catherine W. 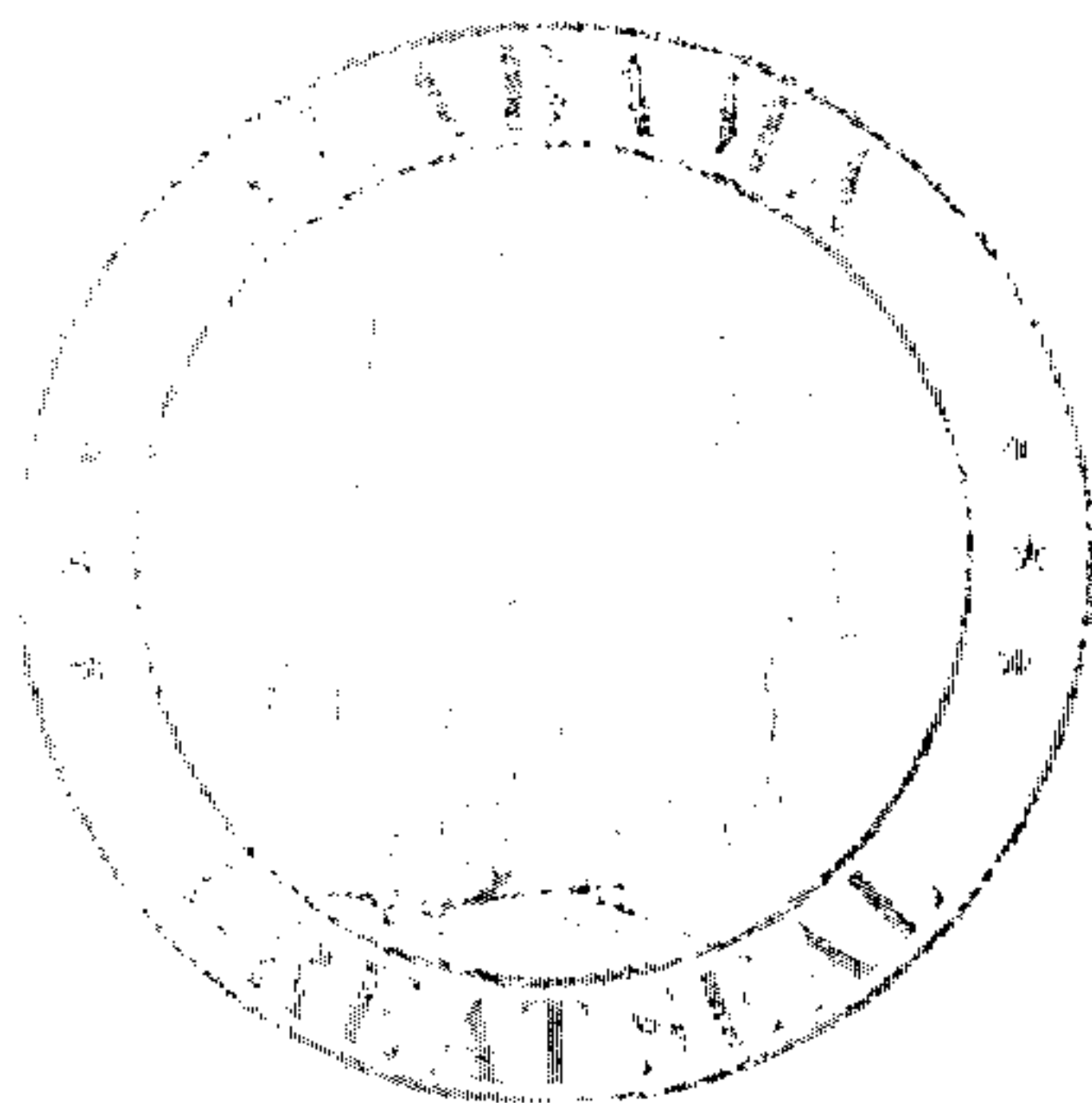
