# Certificate of Trust

The Trustees are authorized to sell, auction, convey, exchange, lease or rent, or to grant options for or in connection with such purposes, or otherwise dispose of all or any portion of the trust property, in such manner and upon such terms and conditions as the Trustees may consider in the best interest of the Trust. To invest and reinvest the Trust and the proceeds of sale or disposal of any portion thereof, in such loans, bonds, mortgages, common Trust funds, or other property, real or personal, or to purchase options for such purposes, or to exercise options, rights or warrants, to purchase other property, as to the Trustees appear in the best interest of the Trust.
6. The Trust is a **non- revocable** trust. The trust will remain in effect until the death of Martha Ann Muehlbauer. Upon her death, any real property shall be sold and the proceeds, together with the remaining Trust property shall be distributed equally among Edwin P. Muehlbauer, Jr., Candice J. Shockley and Laura J. Stone.
7. Title to Trust property may be taken in the following name: **Trust for the Benefit of Martha Muehlbauer, as established by the Last Will and Testament of Edwin P. Meuhlbauer, by deed dated 3/10/2007 and recorded in Instrument No. 2007-131960**
8. The Trust has not been revoked and there have been no amendments limiting the powers of the Trustees over trust property.





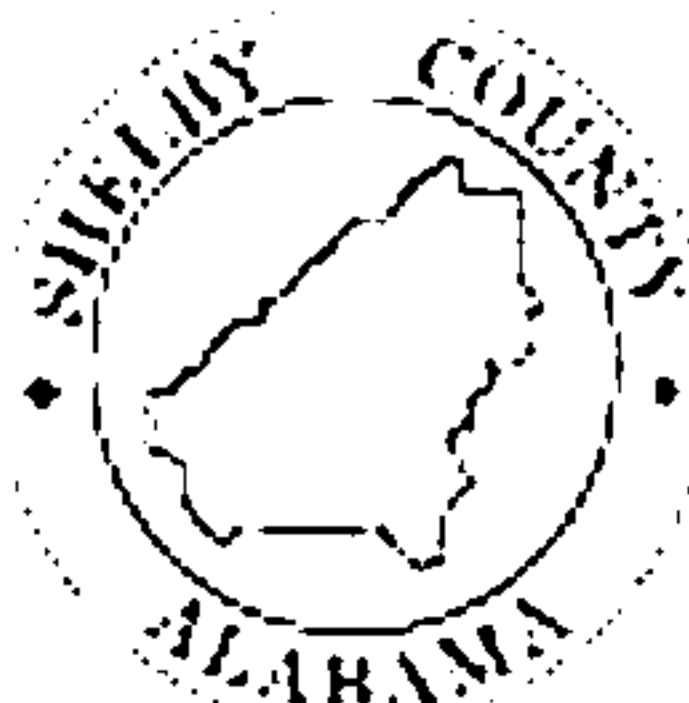
