FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on August 15, 2001, to-wit: Joel S. Williams and Kristy H. Williams, husband and wife, executed a mortgage to Southeastern Mortgage of Alabama, L.L.C., its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on August 22, 2001, in Instrument Number 2001-36010 and re-recorded on November 30, 2001 in Instrument Number 2001-52086, and re-recorded on August 07, 2002 in Document Number 20020807000370190, and modified by that certain Loan Modification Agreement recorded on January 25, 2011, in Instrument Number 20110125000025340, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which said mortgage was subsequently assigned to GSMPS MORTGAGE LOAN TRUST 2006-RP1, MORTGAGE PASS-THROUGH CERTIFICATES, SERIES 2006-RP1, U.S. BANK NATIONAL ASSOCIATION, AS TRUSTEE, by assignment recorded November 12, 2013, and recorded in Instrument Number 20131112000445380, Probate Records of Shelby County, Alabama; and


