Blake and Shirley F. Blake**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of **Shelby**, State of Alabama, to-wit:

Lot 38B, according to The Cottages of Danberry Resurvey No. 3, as recorded in Map Book 41, Page 80, in the Probate Office of Shelby County, Alabama.

Subject To:

1. Ad valorem taxes for 2014 and subsequent years not yet due and payable until October 1, 2014. Existing covenants and restrictions, easements, building lines and limitations of record.
2. Ad valorem taxes and assessments for the current tax year and all subsequent tax years thereafter.
3. All mineral and mining rights not owned by Grantor.
3. All applicable zoning ordinances.
4. 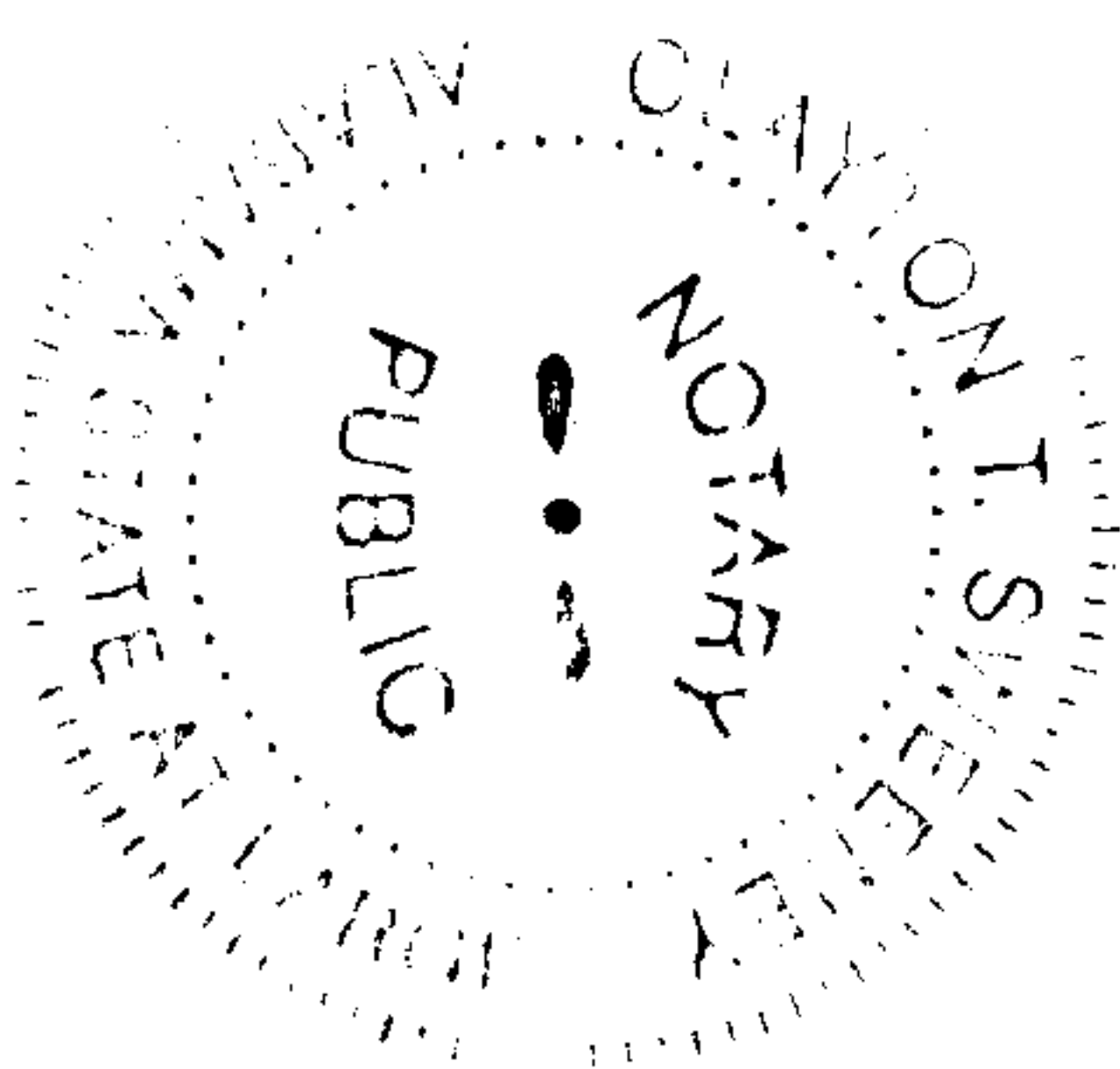

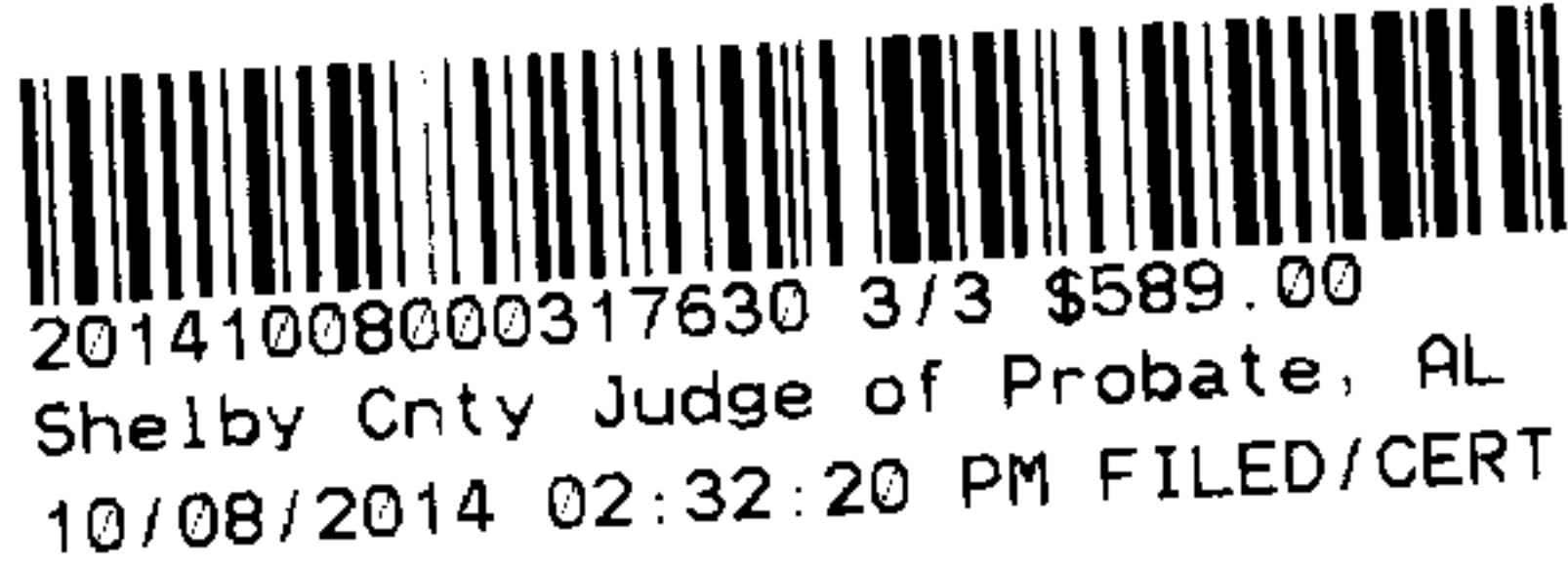
