FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 9th day of October, 2009, Wanda C. Stokes, an unmarried woman and Cynthia Bolding, an unmarried woman, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc. acting solely as a nominee for Aliant Bank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument # 20091125000437860, said mortgage having subsequently been transferred and assigned to Nationstar Mortgage LLC, by instrument recorded in Inst. No. 20140701000198730, in the aforesaid Probate Office ("Transferee"); and

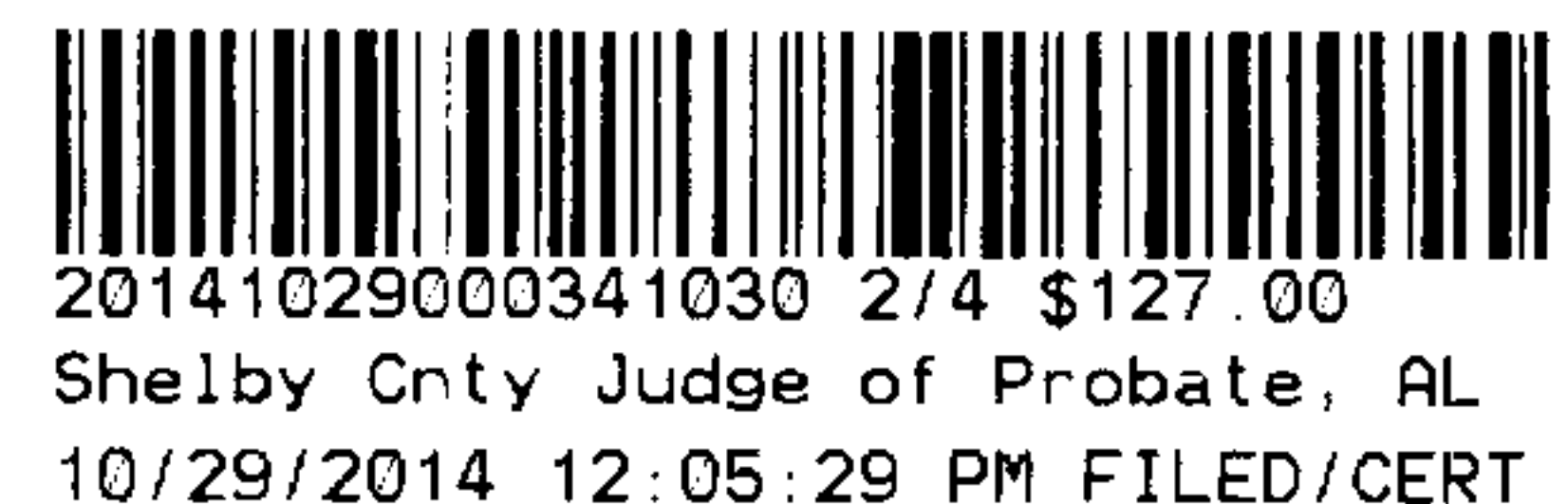
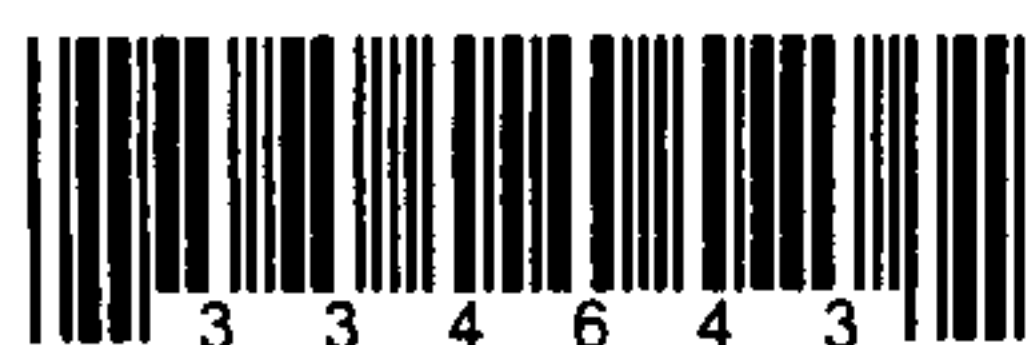

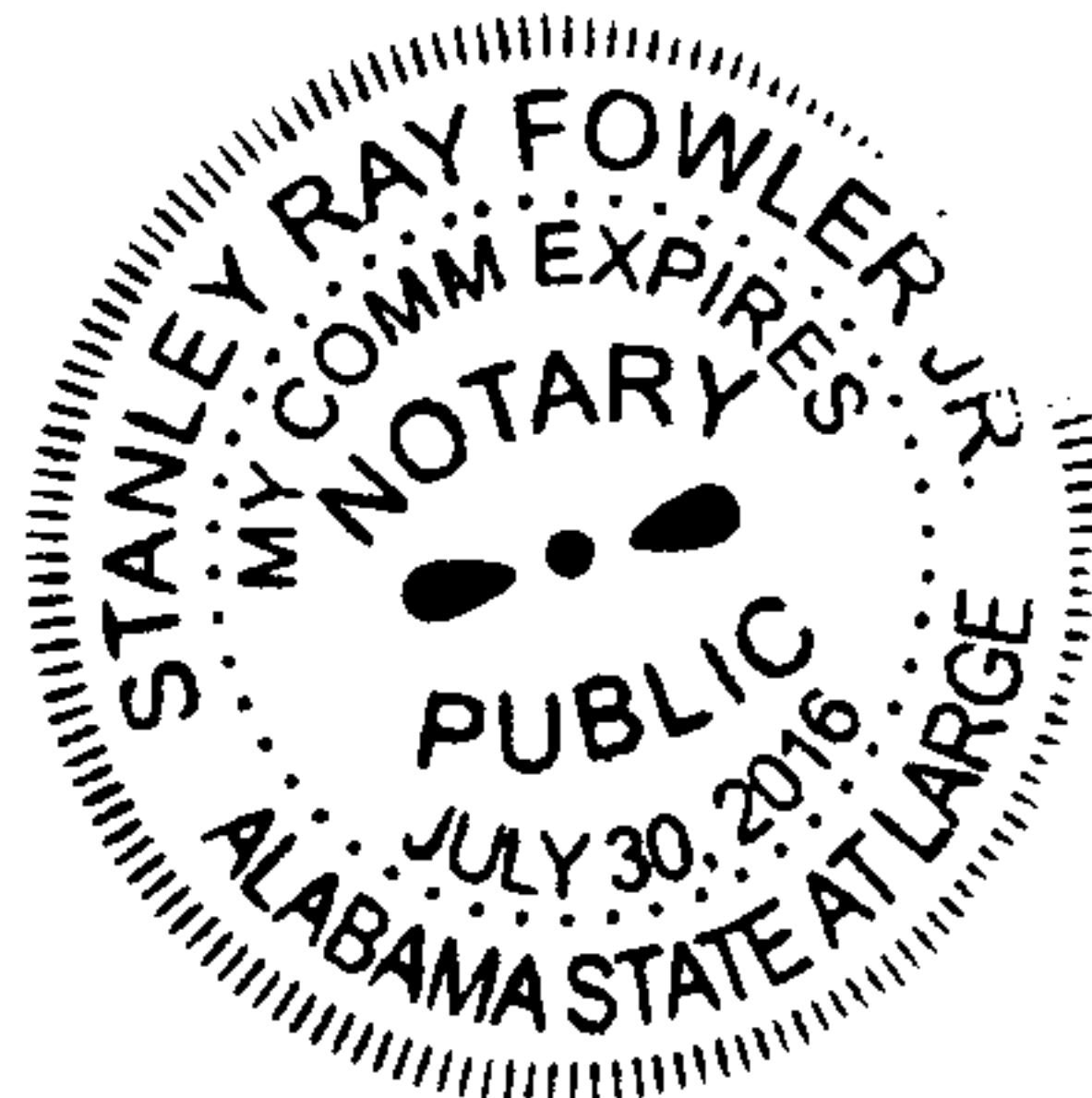
