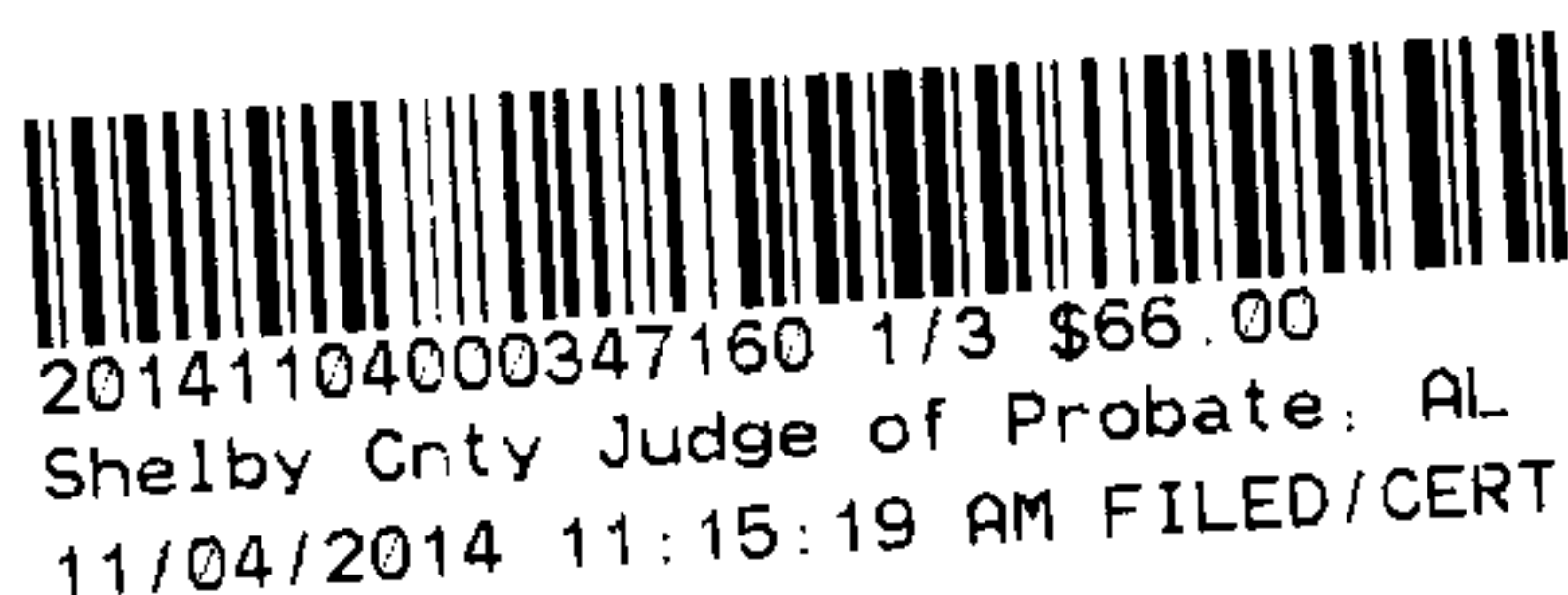
That in consideration of Four Hundred Fifty One Thousand

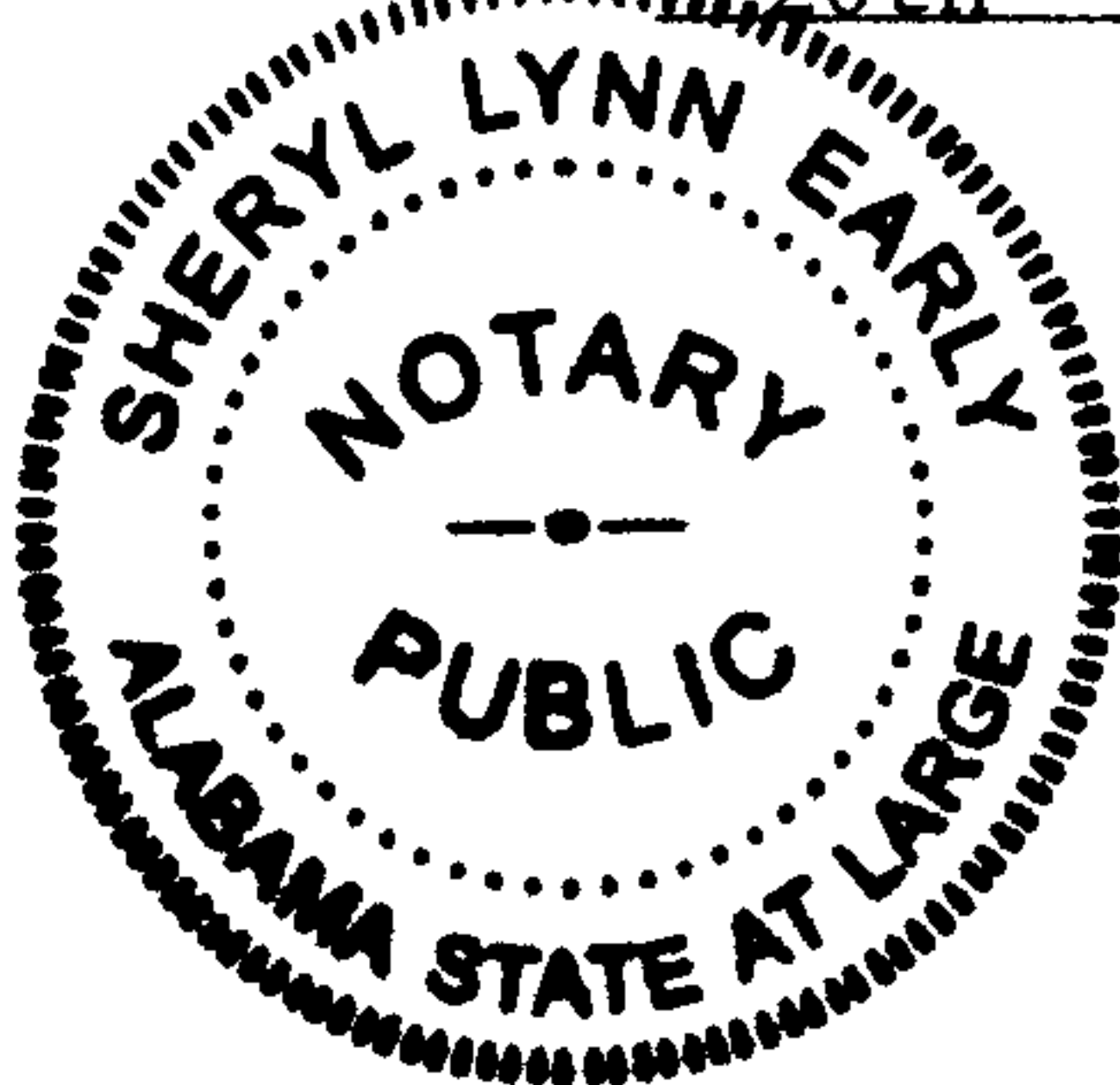

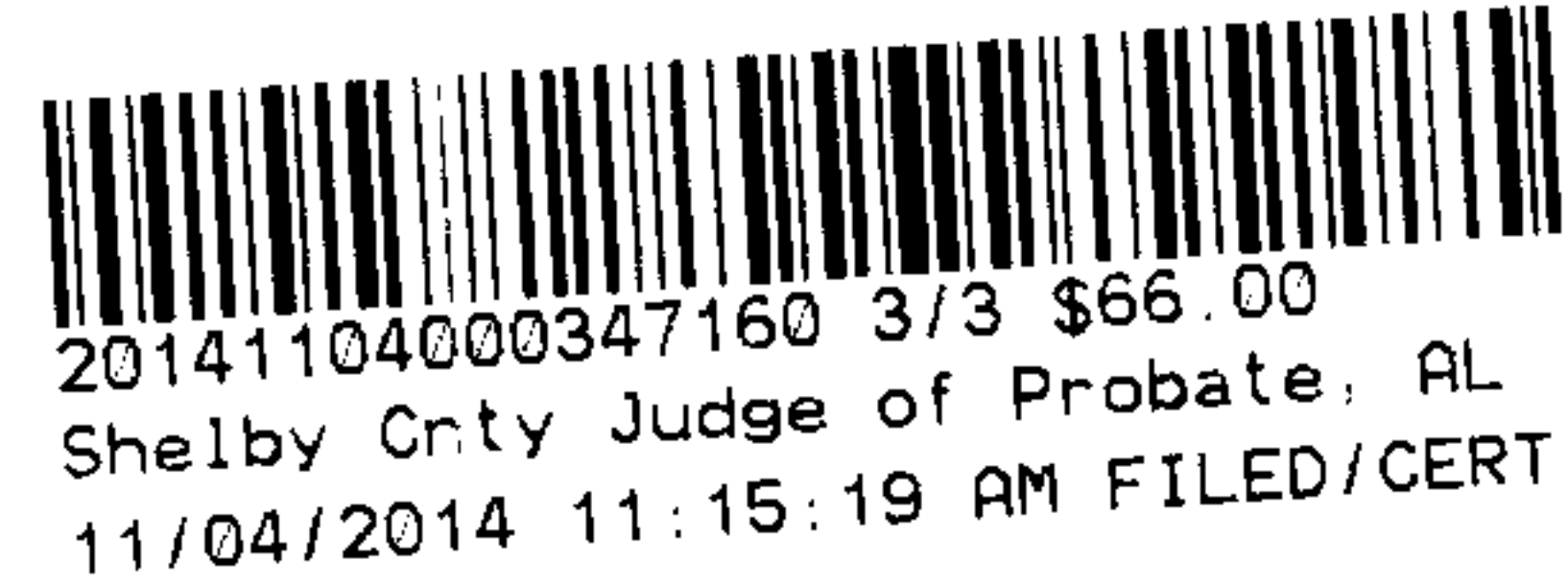
