MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated October 14, 2014, is made and executed between Lula M Glass, an unmarried woman **Lula M. Glass is the surviving grantee in that certain deed recorded in Inst. No. 1993-0180, Probate Office, Shelby County, Alabama. The other grantee, Earnest E. Glass, is deceased, having died 12/9/12 (referred to below as "Grantor") and Central State Bank, whose address is P O Box 180, Calera, AL 35040 (referred to below as "Lender").

MODIFICATION. Lender and Grantor hereby modify the Mortgage as follows:

Increase to Thirty Three Thousand Dollars and 00/100 (\$33,000.00).

CONTINUING VALIDITY. Except as expressly modified above, the terms of the original Mortgage shall remain unchanged and in full force and effect and are legally valid, binding, and enforceable in accordance with their respective terms. Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Mortgage as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Mortgage (the "Note"). 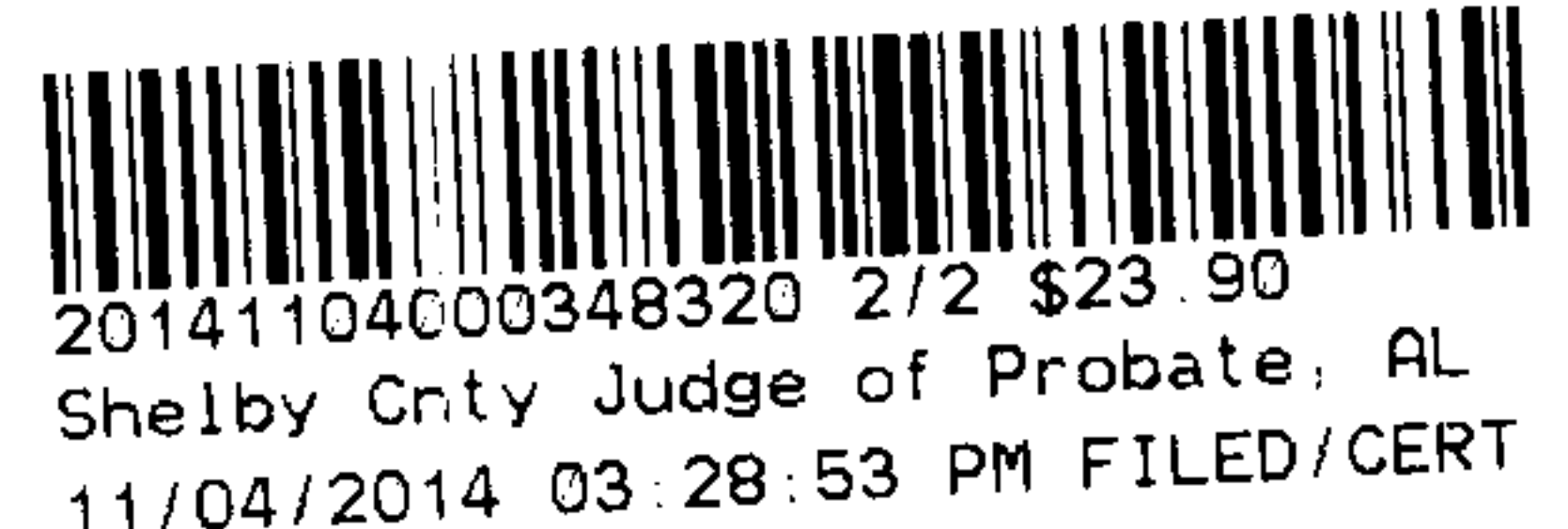
