

# **CERTIFICATE OF FORMATION OF KEW LLC**

The undersigned organizers adopt the following CERTIFICATE OF FORMATION for the limited liability company named below pursuant to the Code of Alabama 1975, Title 10A, Chapter 5, also known as the "Alabama Limited Liability Company Law," or its successor chapter

## **ARTICLE 1 NAME**

1.01. The name of the limited liability company will be **KEW LLC**.

## **ARTICLE II DURATION**

2.01. Unless terminated sooner by unanimous agreement of the members or a provision under the Alabama Limited Liability Company Act, the limited liability company known as **KEW LLC** will have perpetual duration.

## **ARTICLE III PURPOSES**

3.01. **KEW LLC** has been organized for the purpose of conducting and managing speaking and consulting engagements, and for any other lawful purpose that a limited liability company may conduct.

ADDITIONAL MEMBERS, TERMS, AND CONDITIONS OF ADMISSION**

6.02(b) In addition, the potential new member must be approved by the managers named in Article VIII.

**ARTICLE VII

7.01. **Reservation of Right.** The current membership listed in Article V reserves the right to continue the business after any event of dissociation terminates the continued membership of a member. Unanimous consent of the remaining members to continue the business is required. Nothing in this Article should be construed to mean that **KEW LLC** must continue business after any event of dissociation.

LIMITED LIABILITY**



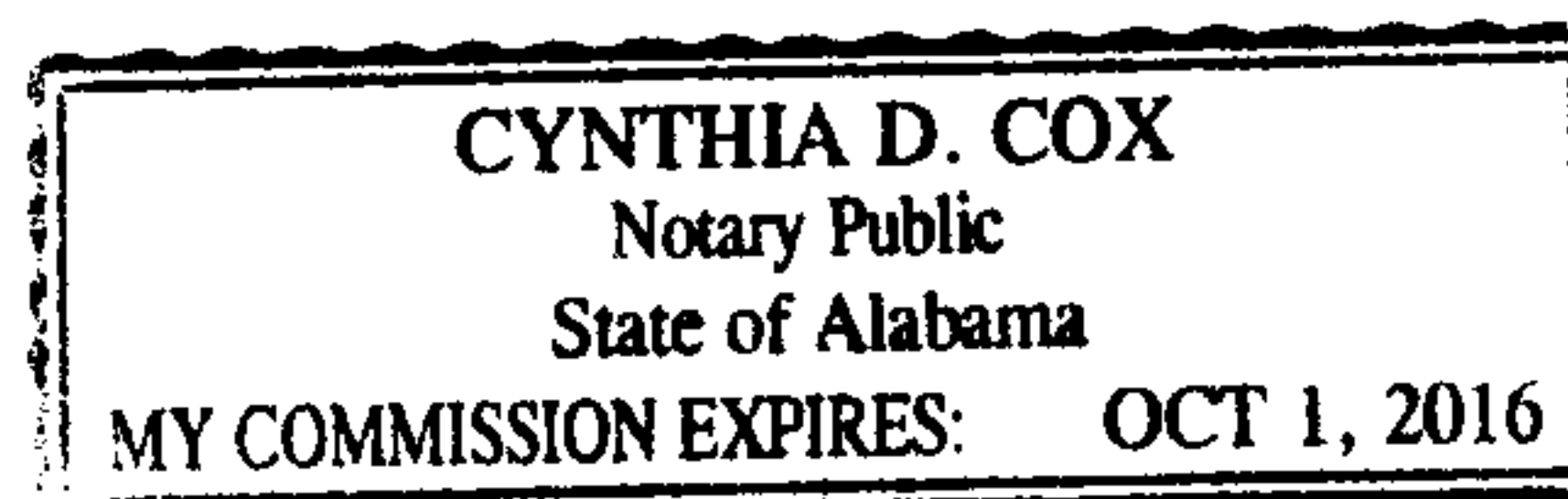

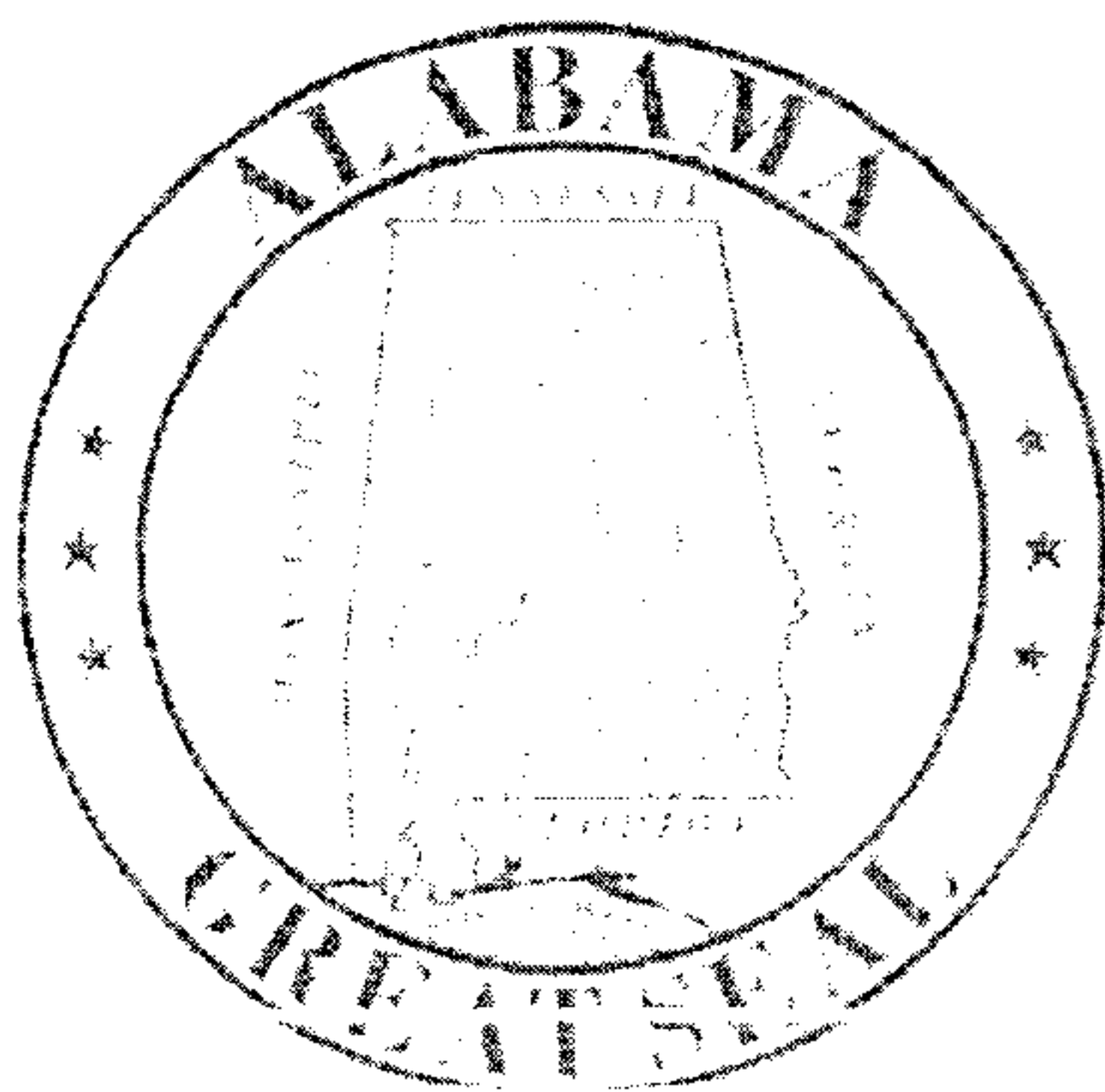
