That in consideration of the sum of **One Hundred Fifty Two Thousand Five Hundred Dollars and No Cents (\$152,500.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Douglas K. Bulger**, a single man (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Huey D. Hartsell and Catherine J. Hartsell**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

Lot 1, in Clearview Estates, as shown by map of said subdivision recorded in Map Book 7, Page 43, in the Probate Office of Shelby County, Alabama.

Property may be subject to all covenants, restrictions, conditions, easements, liens, set back lines, and other rights of whatever nature, recorded, and/or unrecorded.

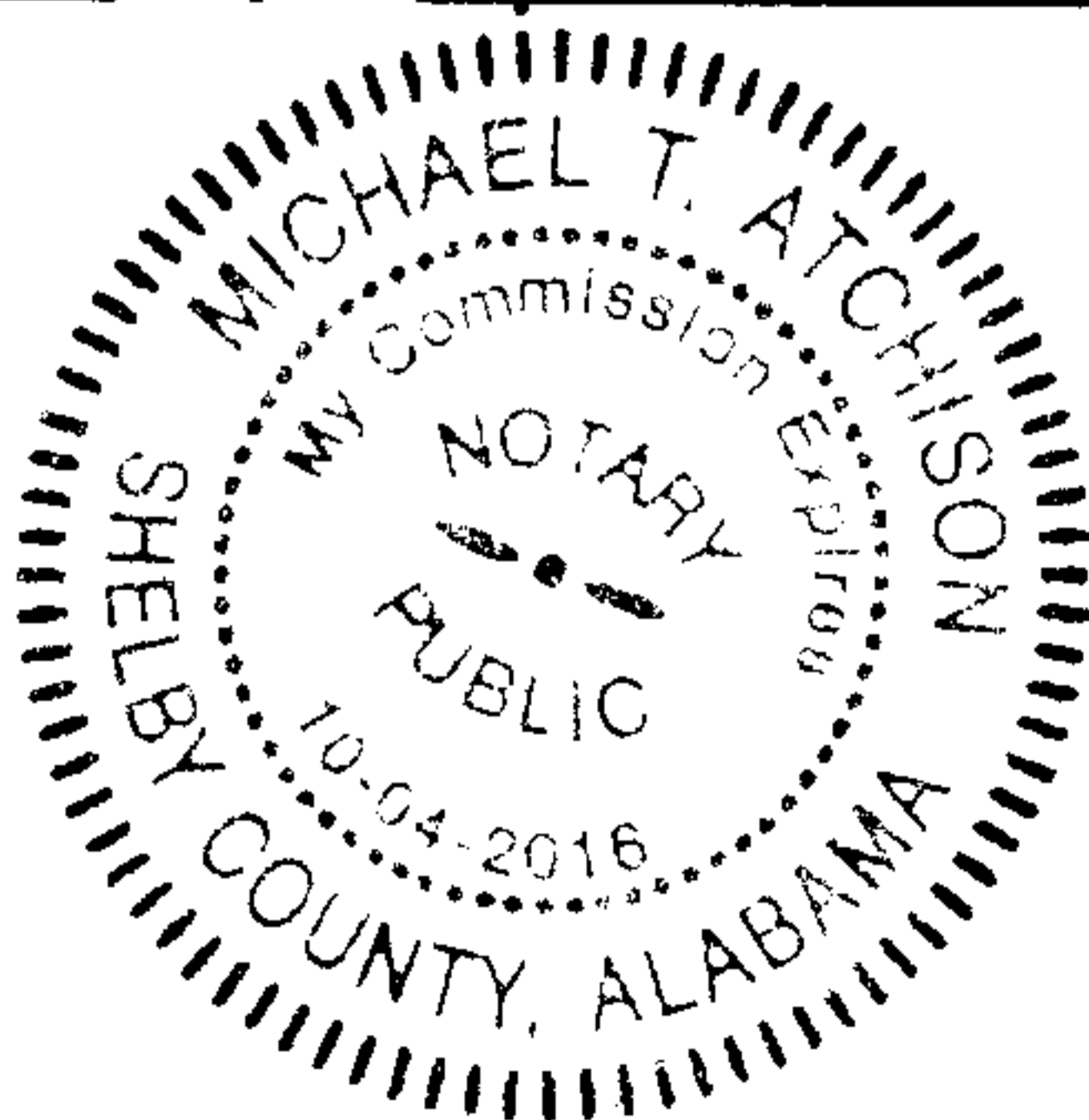
