ARTICLES OF ORGANIZATION

OF

2911 ENTERPRISES, LLC

The undersigned, Matthew T. Bass and Stephanie G. Bass, desiring to organize a limited liability company under the Alabama Business and Nonprofit Entities Code and the Alabama Limited Liability Company Law, adopt and subscribe their names to the following Articles of Organization and Certificate of Formation.

ARTICLE I

NAME OF LIMITED LIABILITY COMPANY

The name of the limited liability company shall be 2911 Enterprises, LLC.

ARTICLE II

PERIOD OF DURATION

The period of duration of the limited liability company shall be perpetual.

ARTICLE III

PURPOSES FOR WHICH LIMITED LIABILITY COMPANY FORMED

The purposes for which the limited liability company is formed and the powers which it shall have in furtherance of its purposes are:

- 1) To engage in and carry on the business of operating a business concern; and

- 2) To transact any and all lawful business for which limited liability companies may be organized under the Alabama Limited Liability Company Law and the Alabama Business and Nonprofit Entities Code, including but not limited to, the powers given in §10A-1-2.11, §10A-1-2.12, and in § 10A-1-2.13 of said Code.

Additional members may be admitted at such times and on such terms and conditions as all members may unanimously agree and as provided in the operating agreement of the limited liability company.


ARTICLE VIII


CONTINUATION OF BUSINESS

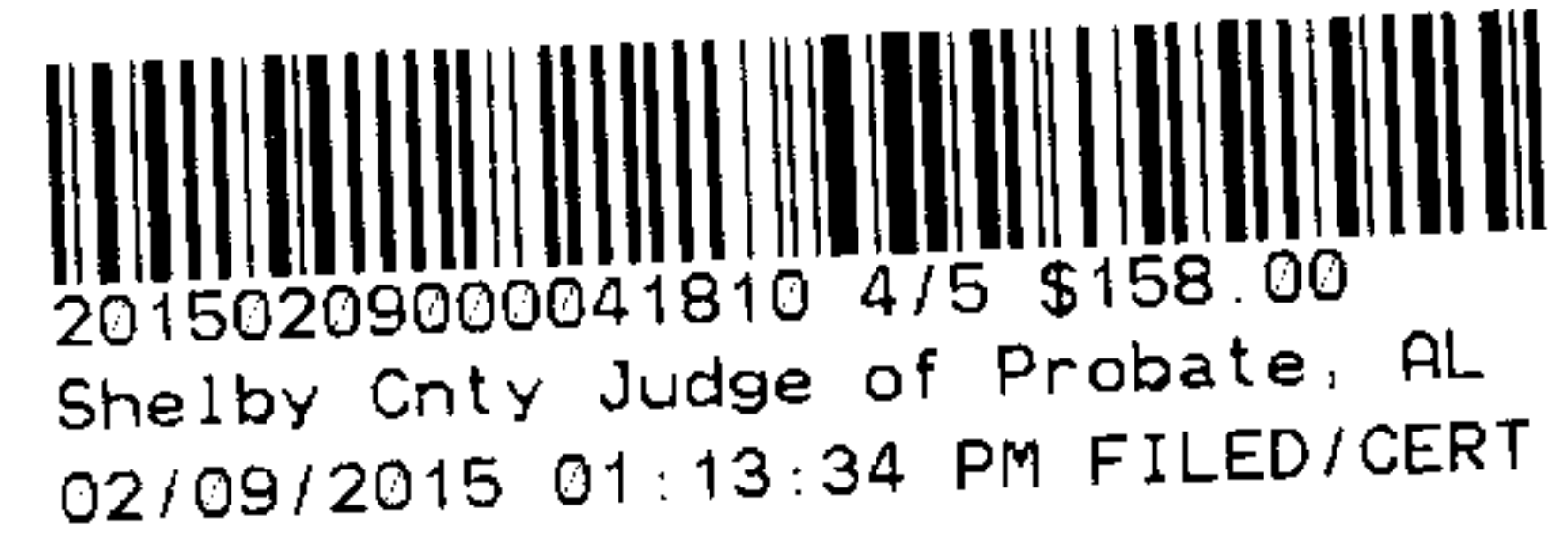
- (i) there is at least one remaining Member or at least one remaining Member and a new Member is admitted; and
