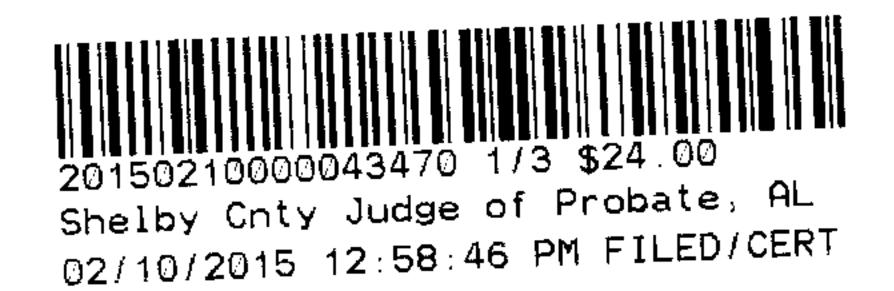

## FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on March 1, 2013, to-wit: Margie G. Mason, a single person, executed a mortgage to Mortgage Electronic Registration Systems, Inc. solely as nominee for U. S. Bank N. A., its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on March 15, 2013, in Instrument No. 20130315000108890, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which said mortgage was subsequently assigned to U.S. Bank National Association, by assignment recorded August 4, 2014, in Instrument No. 20140804000241050, Probate Records of Shelby County, Alabama; and
