FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on March 1, 2013, to-wit: Margie G. Mason, a single person, executed a mortgage to Mortgage Electronic Registration Systems, Inc. solely as nominee for U. S. Bank N. 


