

#### ARTICLES OF ORGANIZATION

## **OF**

# INTERGRATED WASTE SERVICES, L.L.C.

Pursuant to the Code of Alabama, § 10-21-0, et Seq., the undersigned hereby adopt the following Limited Liability Company Articles of Organization:

#### ARTICLE I

# NAME

The name of the Limited Liability Company shall be: "INTERGRATED WASTE SERVICES, L.L.C."

## **ARTICLE II**

# **DURATION**

The period of duration of the Company shall be from the date of filing of these Articles of Organization with the Office of the Judge of Probate for Shelby County, Alabama until the first to occur of the following:

- (1) Fifty (50) years from the date of filing of these Articles of Organization, or,
- (2) Dissolution of the Company pursuant to the laws of the State of Alabama or the Operating Agreement of the Company, as in effect from time to time.

#### ARTICLE III

# **PURPOSES**

- (a) To engage in the business of processing and shredding tires and selling such processed and shredded tires for use as tire derived fuel;

- (c) To engage in any industrial, manufacturing, mining, mercantile, trading, agricultural, service or other lawful business of any kind or character whatsoever;
- (d) To act as agent, respective, or receiver of any person, firm, corporation, or governmental entity or instrumentality in respect to any lawful undertaking or transaction;
- (e) To purchase, take, receive, lease or otherwise acquire, own, hold, improve, use and otherwise deal in or with, real or personal property, or any interest therein, wherever situated, and sell, convey, mortgage, pledge, lease, exchange, transfer and otherwise dispose of real or personal property, or any interest therein;
- (f) To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with shares or other interest in, or obligations of, corporation, associations, partnerships, limited liability companies, individuals, or direct or indirect obligations of governmental entities or of any instrumentality thereof;
- (g) To lend money, invest and reinvest its funds and take and hold real and personal property as security for the payment of funds so loaned or invested; and
- (h) To engage in any other lawful act or activity for which limited liabilities companies maybe organized pursuant to the Act.
