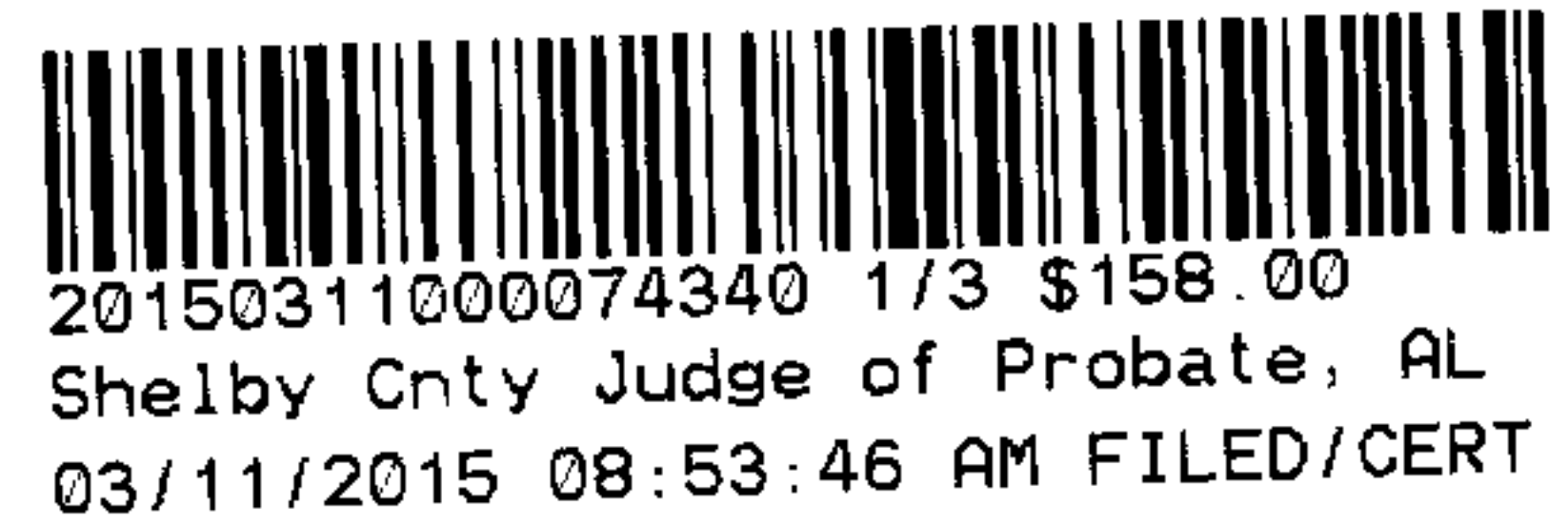

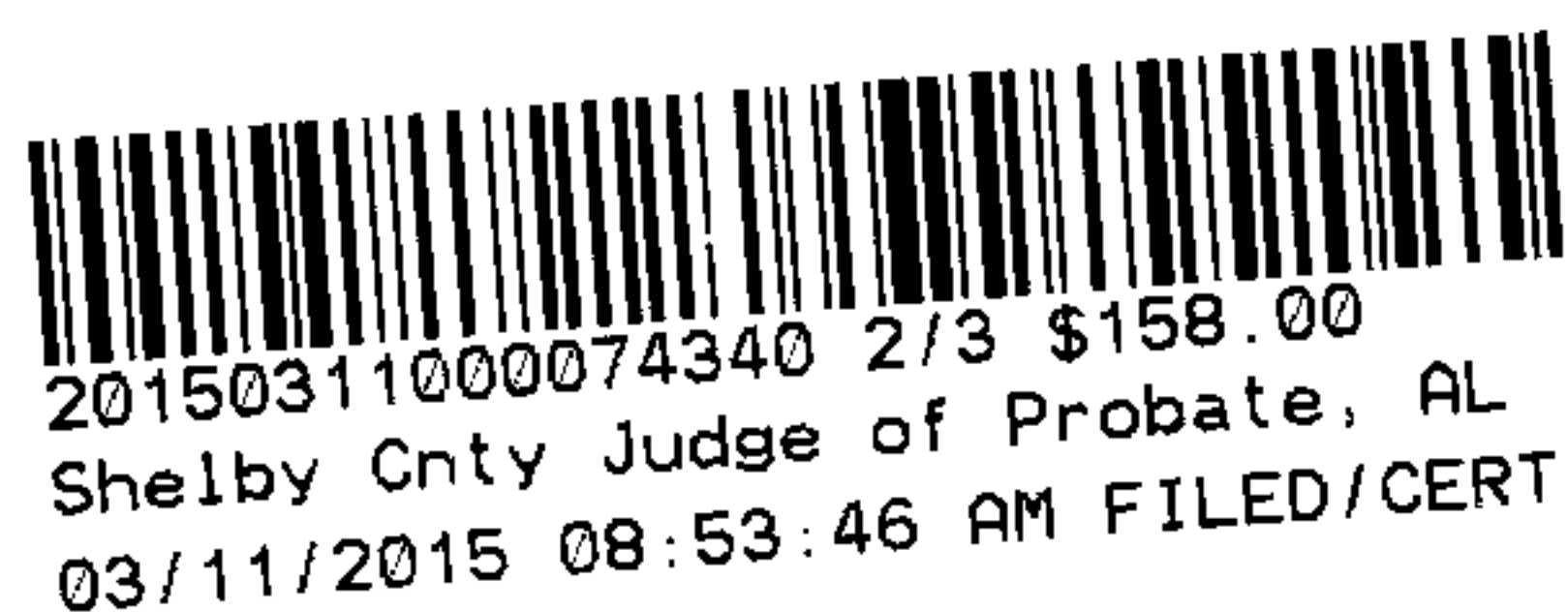
ARTICLE IV

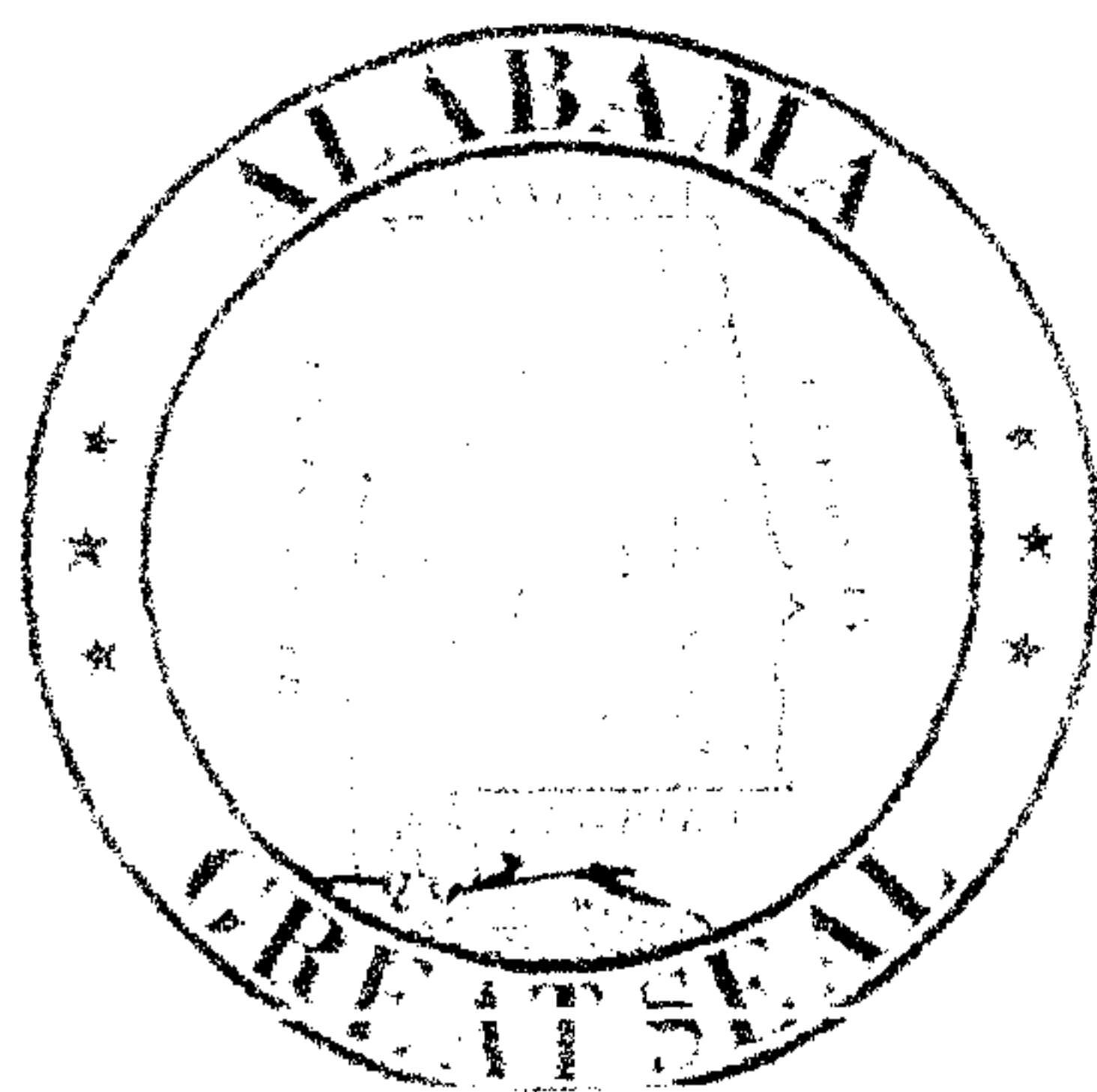
