**Article 1.** The name of the limited liability company is:

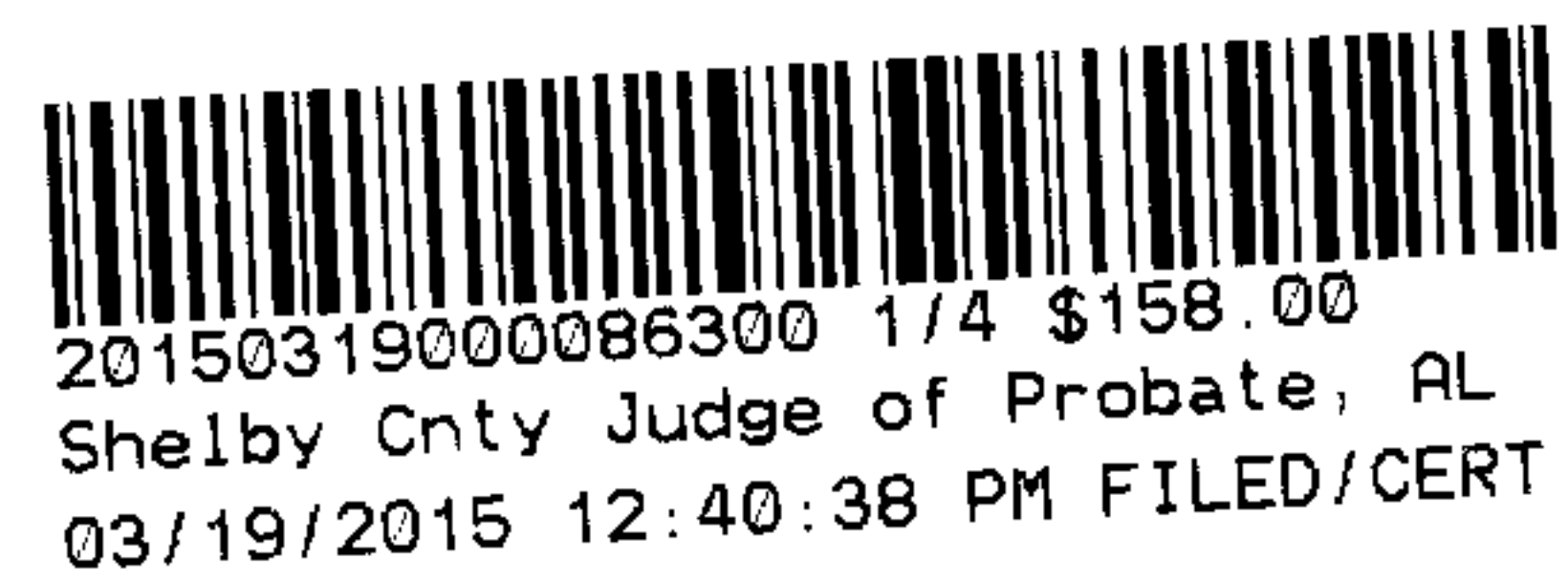
NH Vapes, LLC.



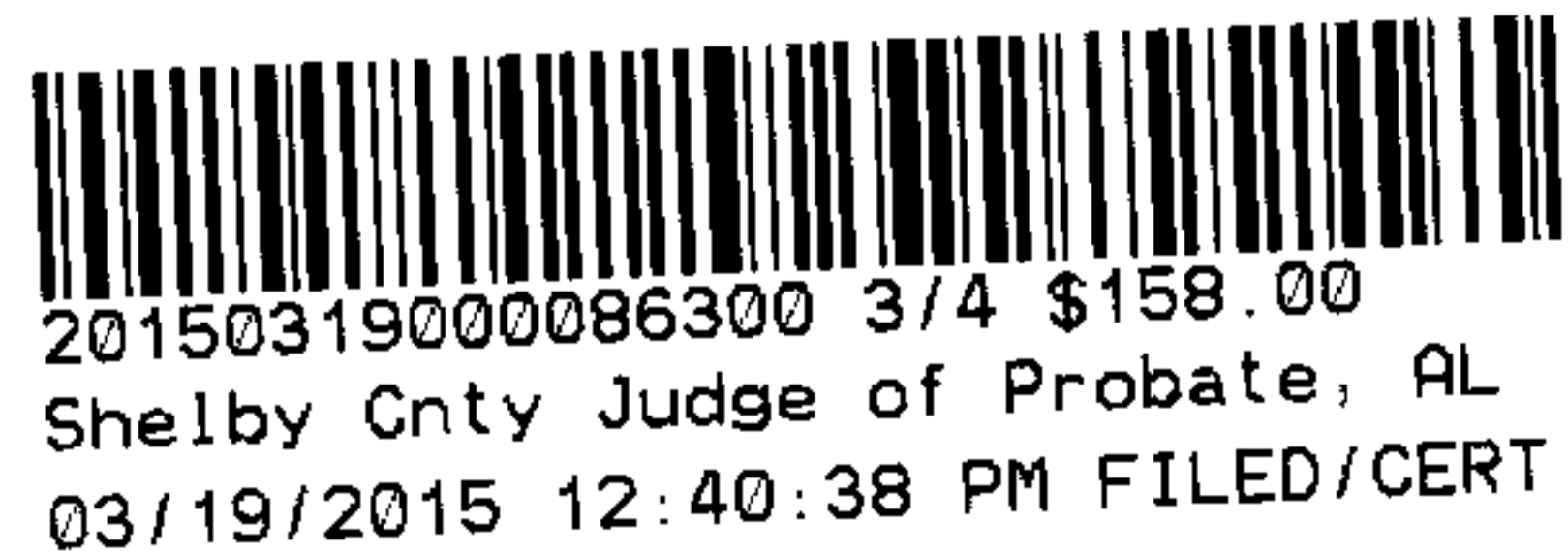

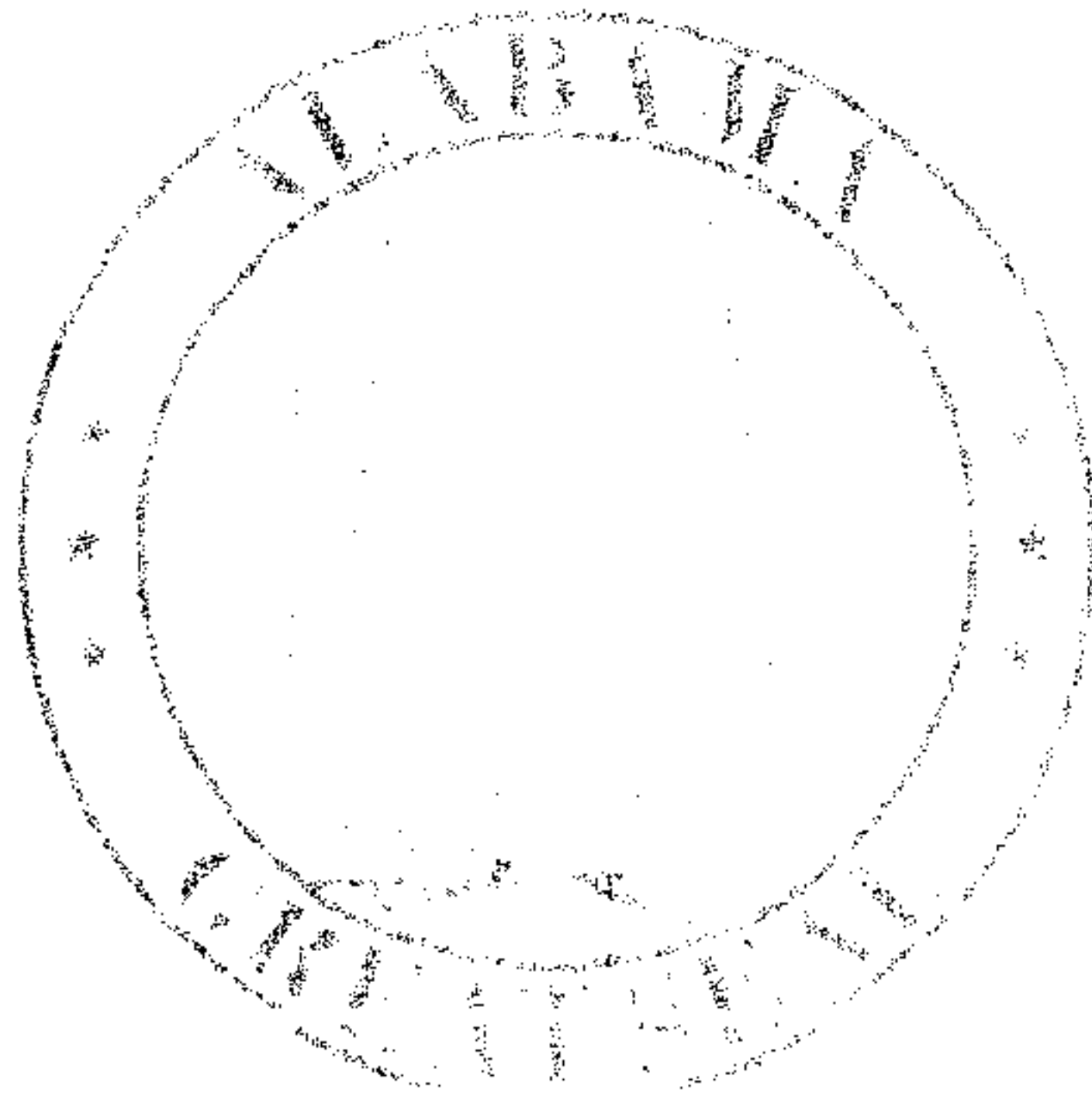
