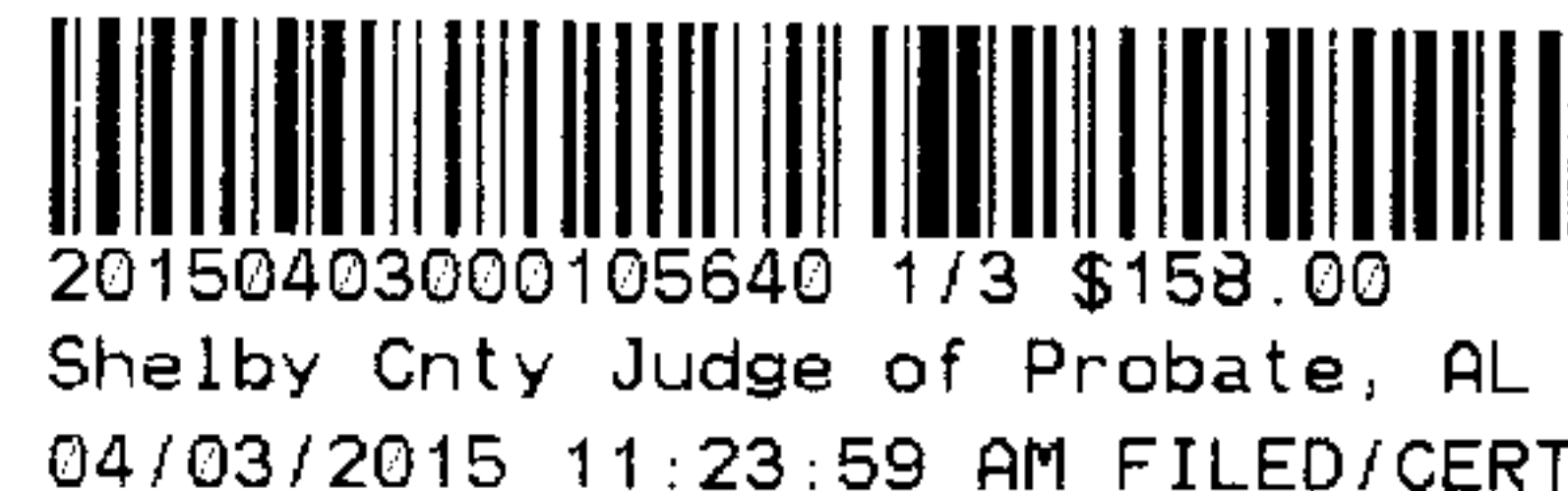


**CERTIFICATE OF FORMATION
OF
THE CROSS AND THE TOWERS, INC.**

Pursuant to the provisions of the Alabama Business and Nonprofit Entity Code, as amended (codified at sections 10A-1-1.01 *et seq.*, *Code of Alabama* (1975)) (the “Act”), The Cross and the Towers, Inc. adopts the following Certificate of Formation for the purpose of incorporating and organizing a nonprofit corporation:

1. The name of the nonprofit corporation is The Cross and the Towers, Inc. (the “Corporation”).
2. The duration of the Corporation is perpetual.
3. The purpose of the Corporation is to engage exclusively in charitable, religious, and educational activities as described in sections 170(c)(2) and 501(c)(3) of the Internal Revenue Code of 1986, as amended (the “Code”), or the corresponding sections of any future federal tax code, and the regulations promulgated thereunder, and to promote and advance such purposes by any activity in which a nonprofit corporation organized under the Act may engage.
4. The Corporation will not have members.
5. The street address of the initial registered agent shall be c/o Gentle, Turner, Sexton, Debrosse & Harbison, 501 Riverchase Parkway East, Suite 100, Hoover, Alabama 35244, and the name of its initial registered agent at such address is Eddie Sexton.
6. The number of directors constituting the initial Board of Directors of the Corporation is three (3) and the names and street addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and qualified are:

7. The name of the incorporator is Scott Perkins, and the street address of the incorporator is 700 Doug Baker Blvd, Suite 7369, Birmingham, AL 35242.

8. The Corporation shall indemnify any director or officer who was or is a party or is threatened, to be made a party to any threatened, pending, or completed action, suit or proceeding, whether civil, criminal, administrative or investigative (other than an action by or in the right of the corporation) by reason of the fact that he is or was a director, officer, employee or agent of the Corporation, or is or was serving at the request of the corporation as a director, officer, employee or agent of another corporation, partnership, joint venture, trust or other enterprise, against expenses (including attorneys' fees), judgments, fines and amounts paid in settlement actually and reasonably, incurred by him in connection with such action, suit or proceeding to the fullest extent permitted by law.

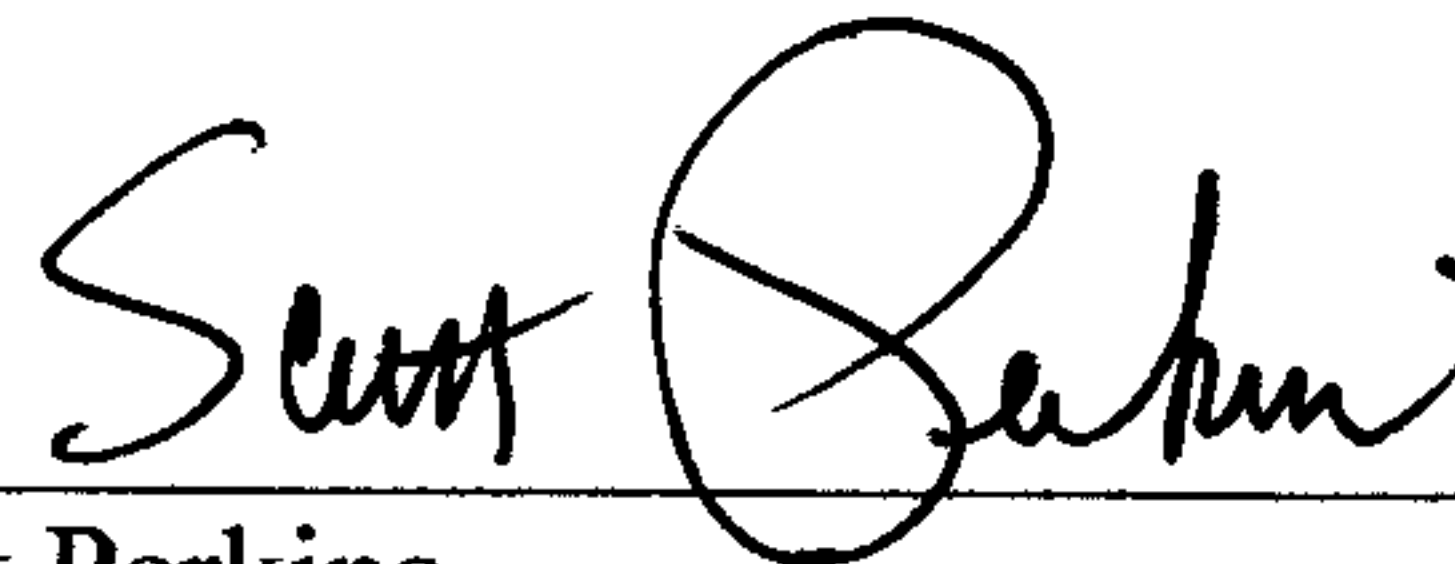
9. Notwithstanding any other provision of this Certificate of Formation:

(a) No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers or other private individuals, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered to or for the Corporation affecting one or more of its purposes. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in, any political campaign on behalf of or in opposition to any candidate for public office.

(b) The Corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Code.

(c) Upon dissolution of the Corporation or the winding up of its affairs, the assets of the Corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Code to an organization that is exempt under Section 501(c)(3) at the time of the Corporation's dissolution, or shall be distributed to the federal government, or a state or local government, for a public purpose.

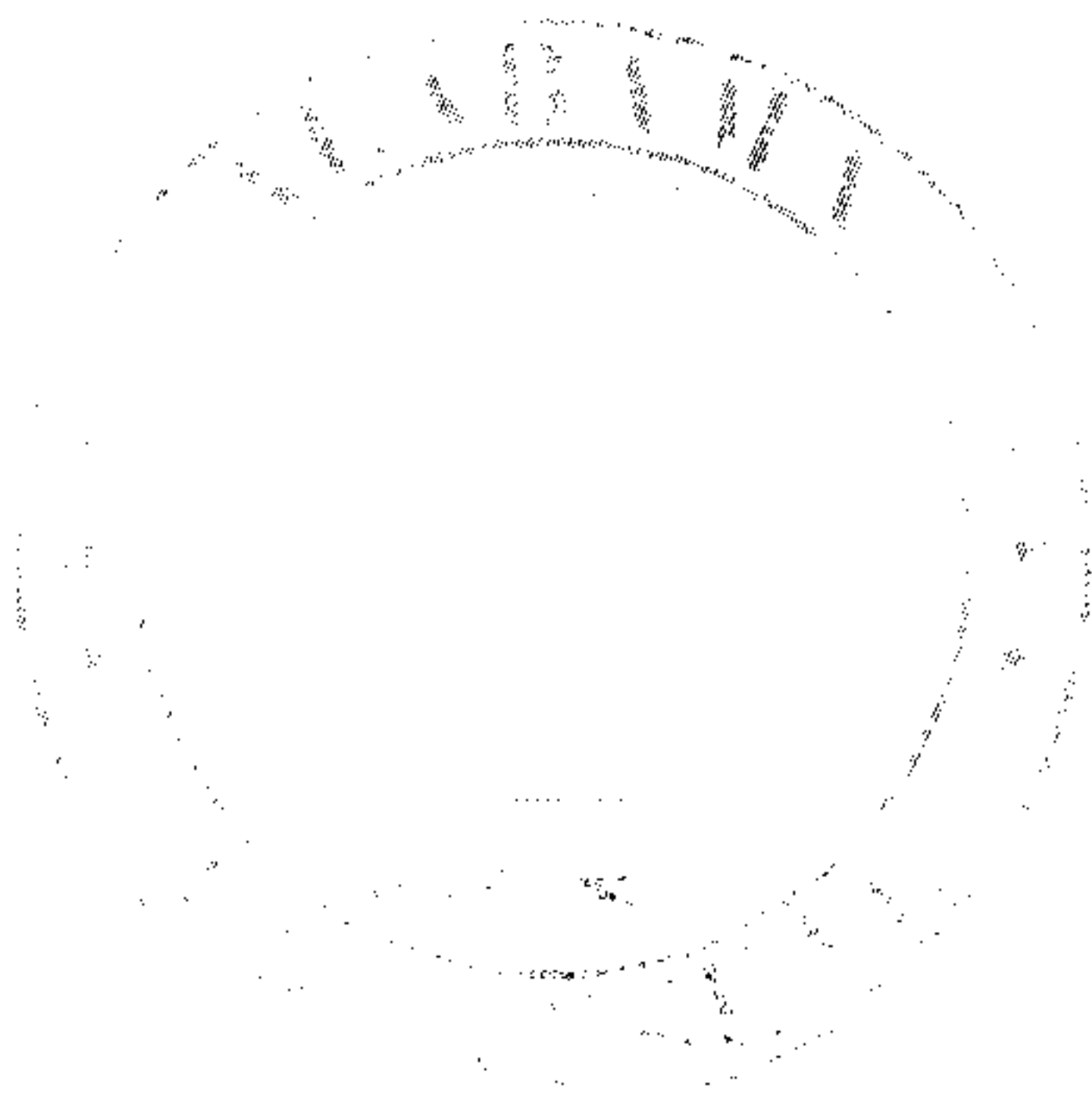
