**ARTICLES OF ORGANIZATION
OF
BLANKENSHIP INSTALL AND CONSTRUCTION SERVICES, LLC**

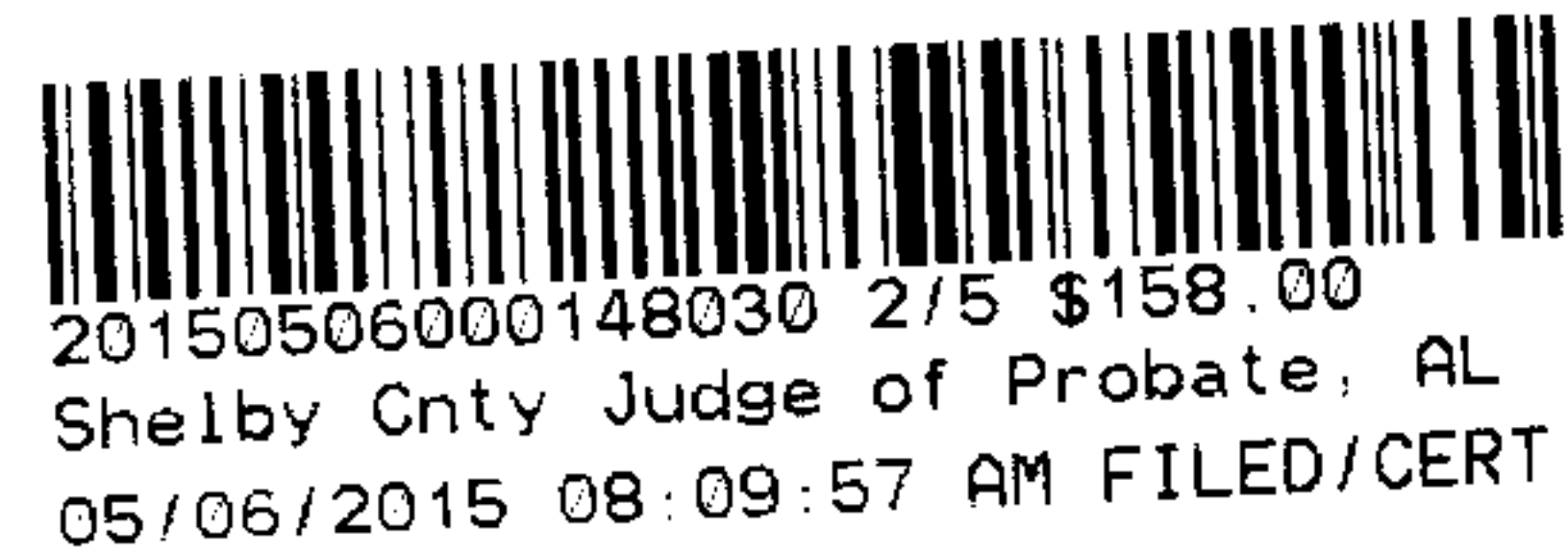
Pursuant to the Provisions of Act No. 93-724 of the 1993 Alabama Legislature or the Alabama Limited Liability Company Act, the undersigned hereby adopts the following Limited Liability Company Articles of Organization:

**ARTICLE I
Name**

The name of the limited liability company (the "Company") is BLANKENSHIP INSTALL AND CONSTRUCTION SERVICES, LLC.

**ARTICLE II
Period of Duration**

The period of duration for the Company is perpetual unless it is sooner dissolved in accordance with the provisions of the operating agreement, or, if there is no operating agreement or if there is no provision in the operating agreement governing the duration of the company, then in accordance with the Alabama Limited Liability Company Act or other applicable law of the state of Alabama.



ARTICLE III

Business Purpose

The Company has been organized for the purpose of providing advice, services and installation for doors, windows, and trim, including but not limited to all other general construction services for the installation and building products of a home or business; and to do those actions which may reasonably be anticipated to be of benefit to the aforementioned business purposes, and also, in cooperation with other companies, partnerships, and individuals, it may become a general partner or a limited partner; and to engage in any lawful act or activity for which a limited liability company may be organized under the Alabama Limited Liability Company Act.

ARTICLE IV

Registered Agent and Office

The address of the Company's initial registered office in Alabama is 1308 Whirlaway Circle, Helena, Alabama 35080. The name of the Company's initial registered agent at that address is Joseph P. Blankenship.

ARTICLE IX

Business Operations

The business of the Company is not and shall not be conducted as a sole proprietorship at any time whatsoever.

ARTICLE X

Business Property

All business property of the Company shall be owned by the Company. All title shall be held in the Company's name unless otherwise agreed upon by the Initial Member, and any future members, in writing. Each Member, by acceptance of the membership rights and privileges in the Company, hereby acknowledges that he, she, or it has no right to require partition of said business property.



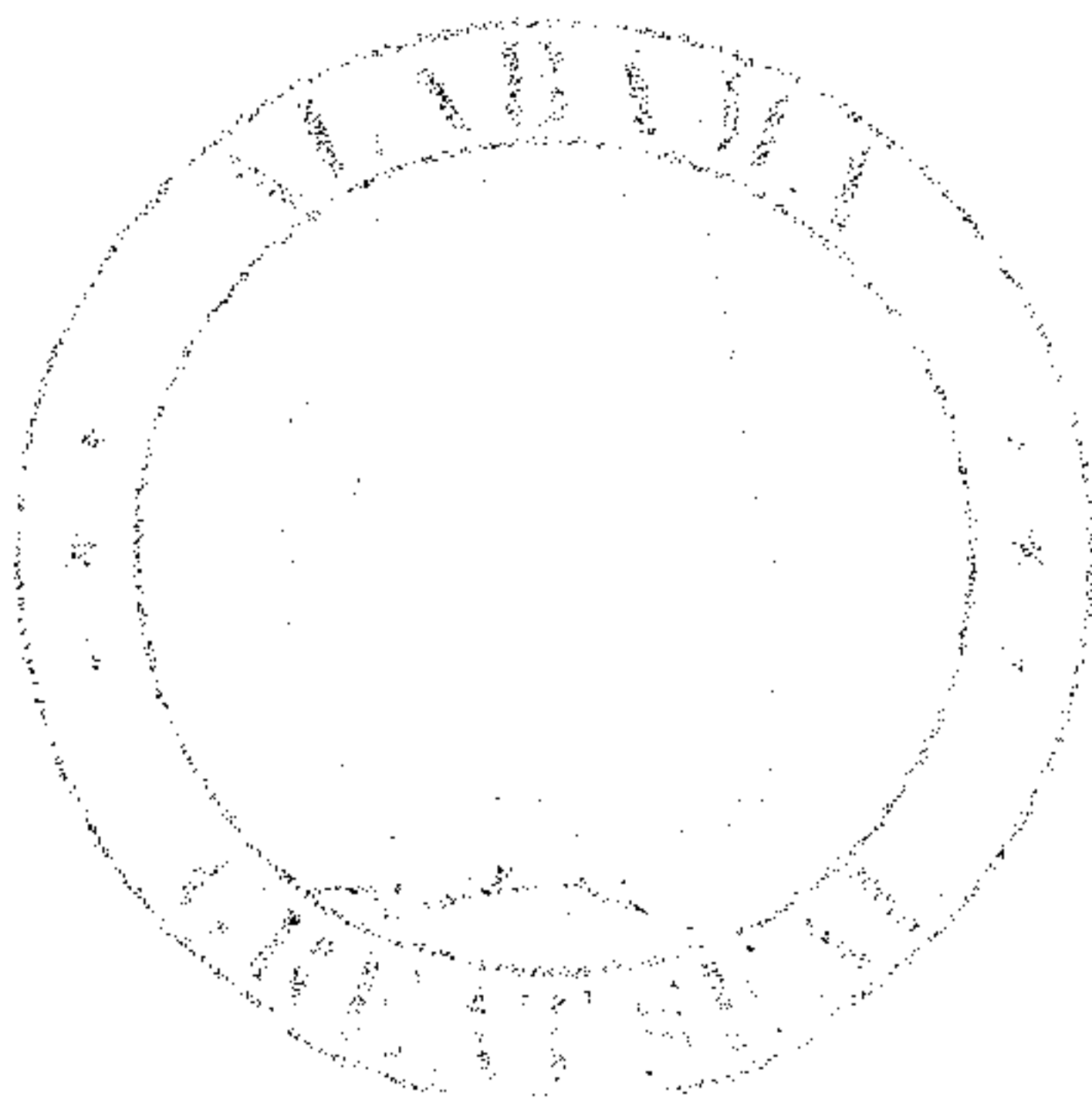
