Know All Men by These Presents: That in consideration of **Three hundred seventy seven thousand three hundred ninety nine and no/100 (\$377,399.00)**, to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Donovan Builders, LLC** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **Vester L. 

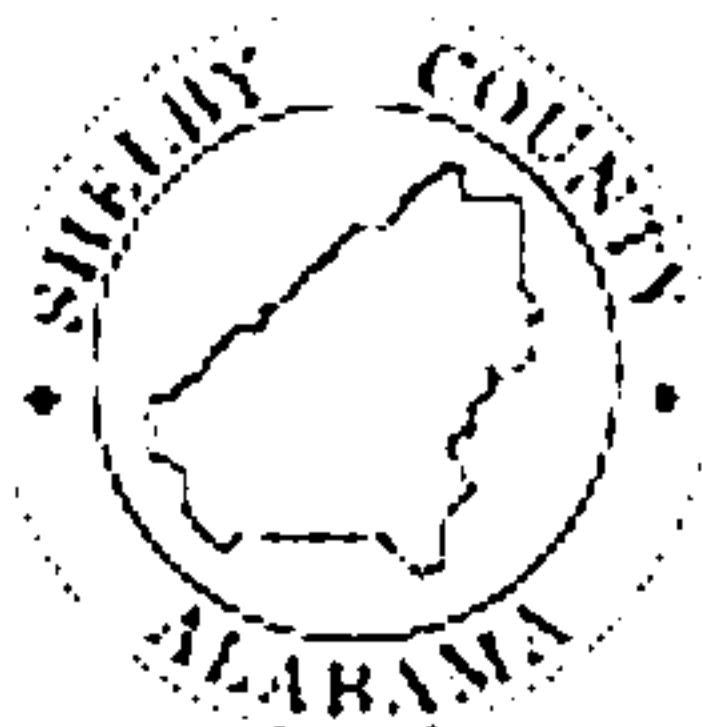
