FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 19th day of August, 2013, Lara E. Vickery, and Daniel Vickery, wife and husband, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for EverBank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20131227000491860, said mortgage having subsequently been transferred and assigned to EverBank, by instrument recorded in Instrument Number 20140203000029610, in the aforesaid Probate Office ("Transferee"); and
