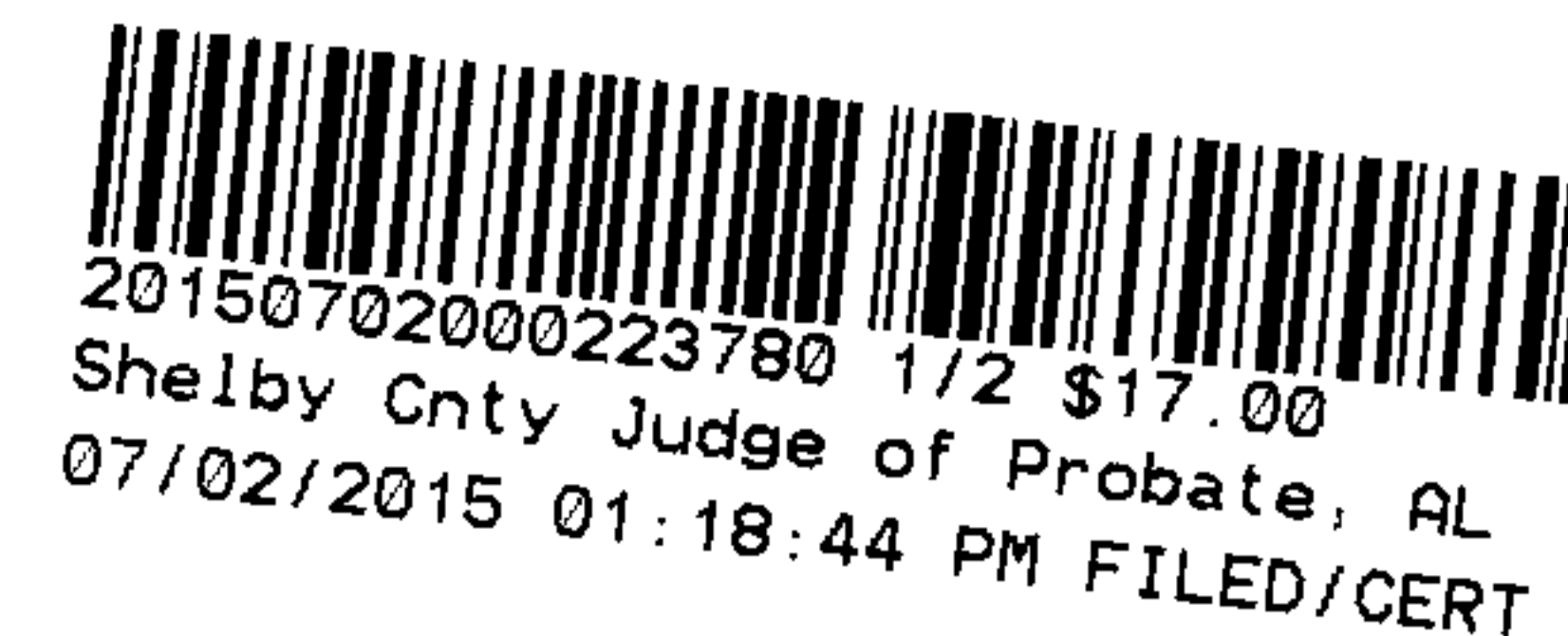

SPECIFIC POWER OF ATTORNEY
