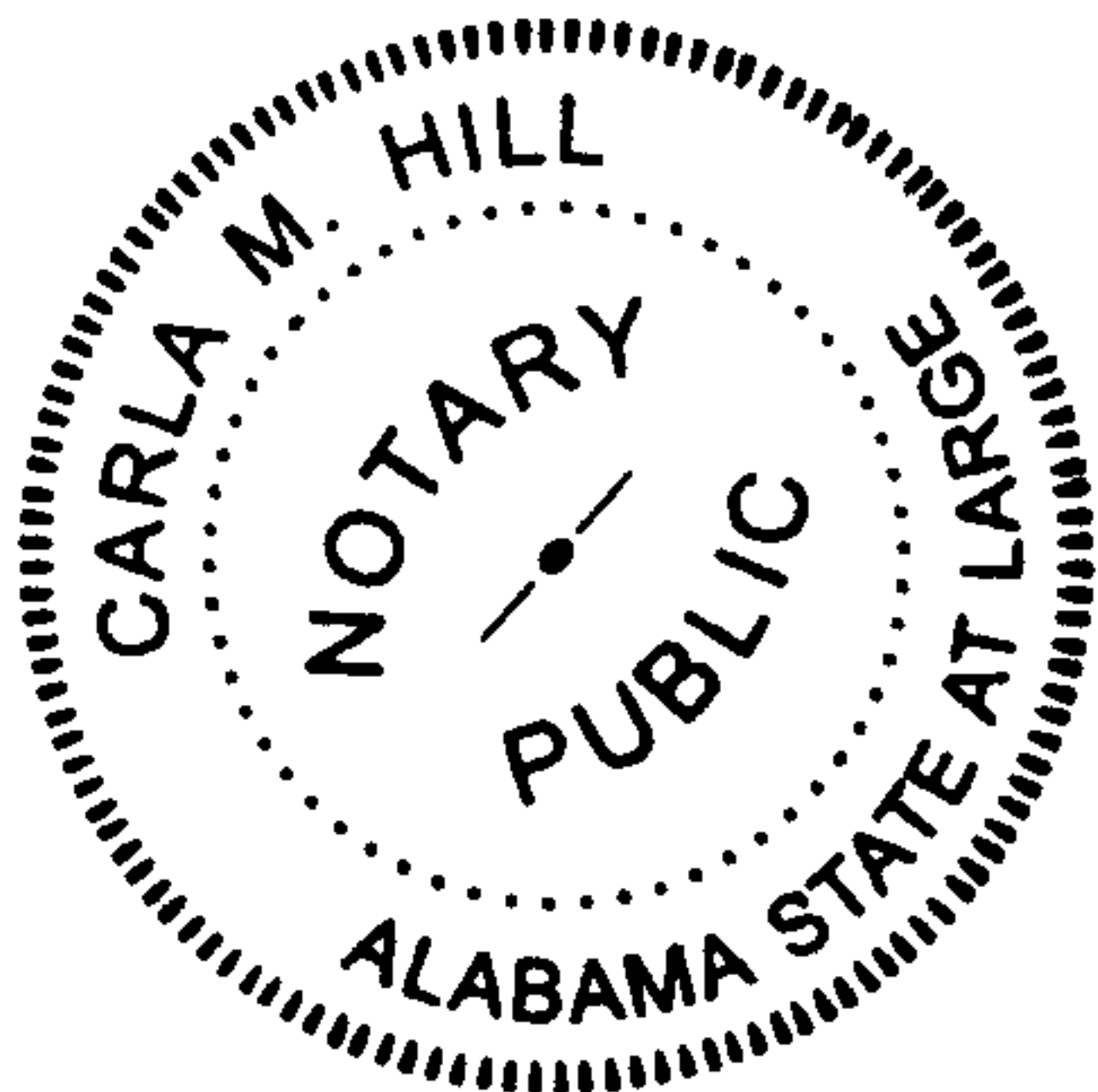

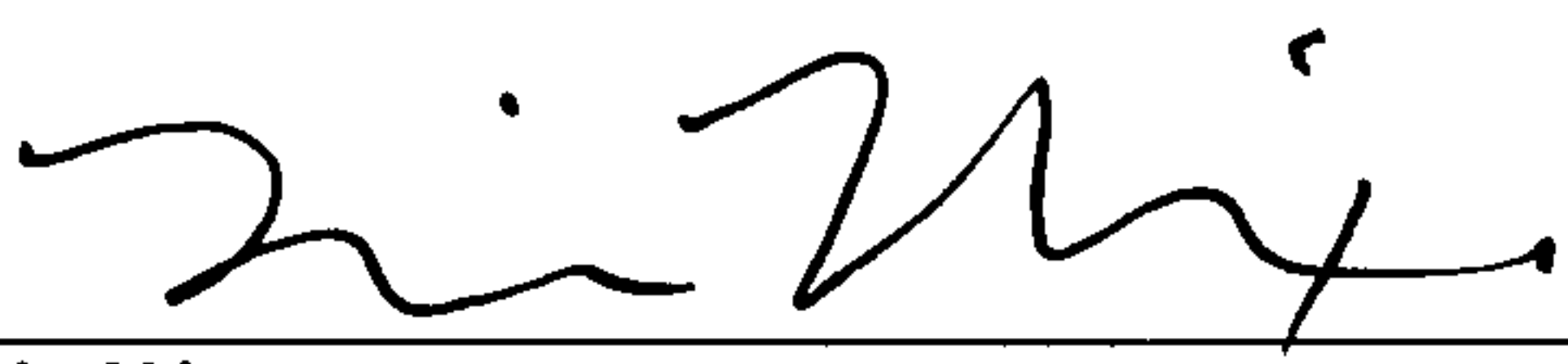
\$347,200.00 of the purchase price recited above has been paid from the proceeds of a

survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

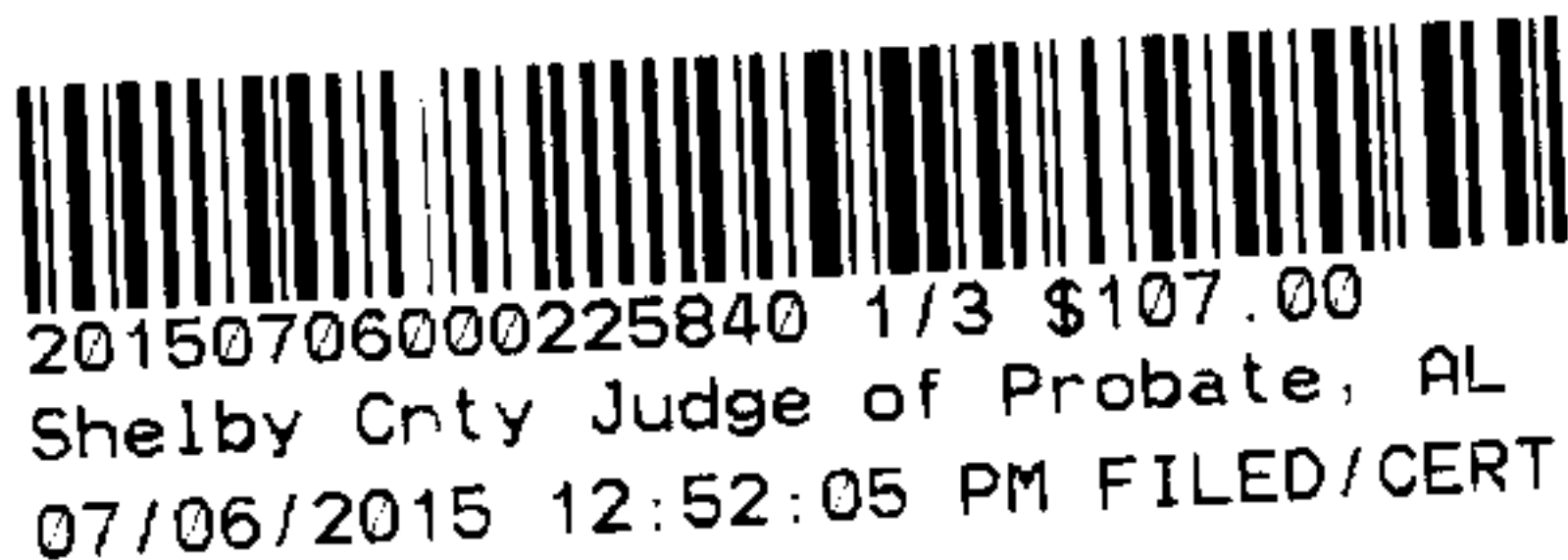
