Subject to existing easements, current taxes, restrictions and covenants, set-back lines, rights of way and mortgages, if any, of record.


\$147050.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.

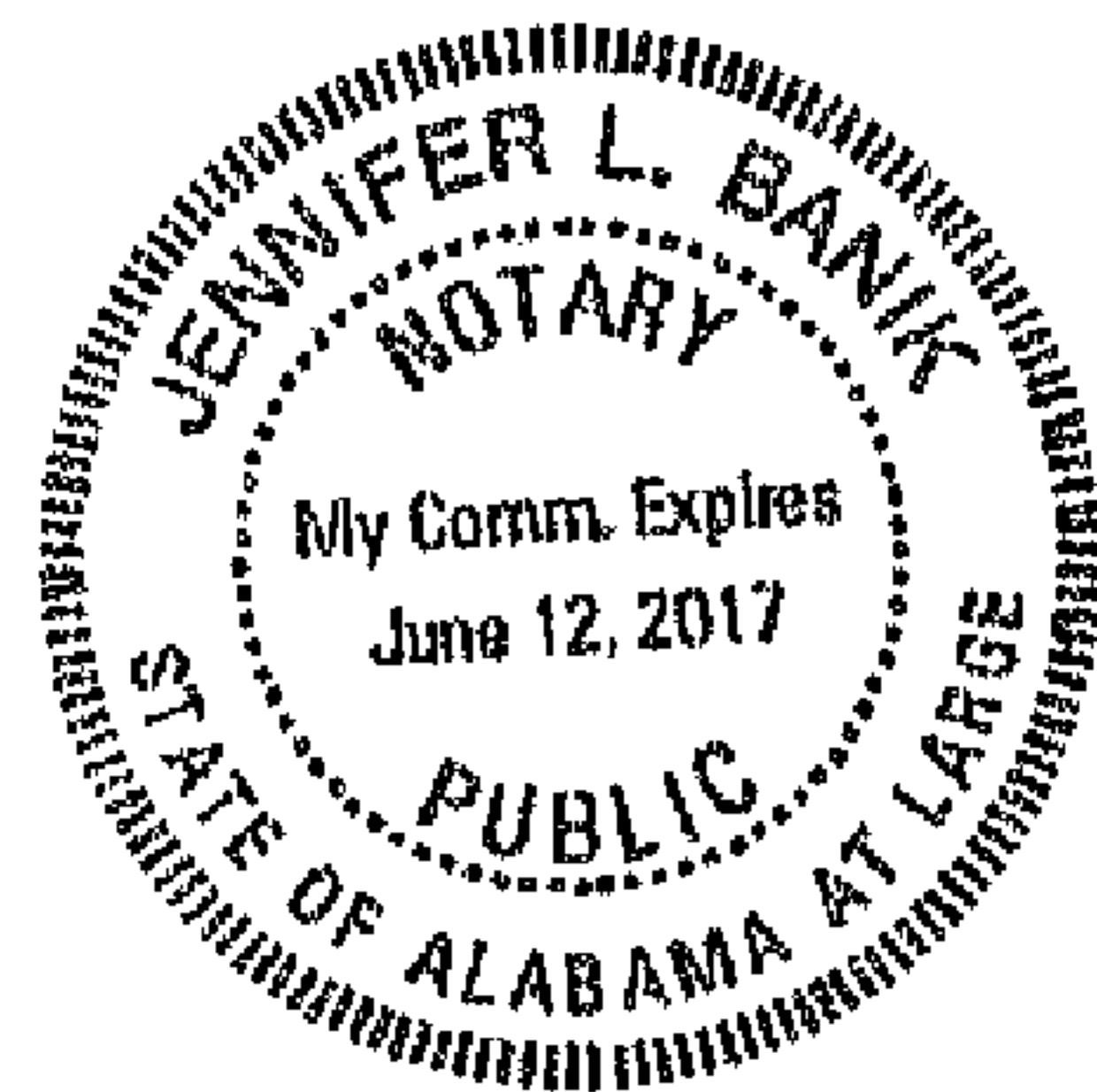

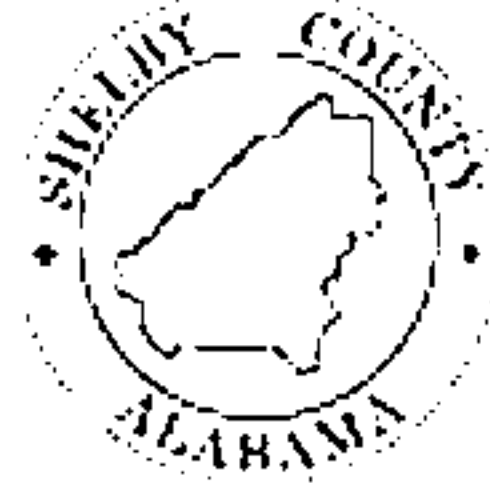
