FARMER, HUSBAND AND WIFE**, (hereinafter referred to as GRANTORS), the receipt whereof is hereby acknowledged, the GRANTORS do hereby give, grant, bargain, sell and convey unto the GRANTEES, **JOHN LANKFORD AND LAURA LANKFORD**, (hereinafter referred to as GRANTEES), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, the following described Real Estate, lying and being in the County of ~~Jefferson~~, State of Alabama, to-wit: *Shelby*

Lot 8A, according to the Survey of Resurvey of Plat 8, Lee Street Estate, as recorded in Map Book 9, Page 148, in the Probate Office of Shelby County, Alabama.


Subject to existing easements, current taxes, restrictions and covenants, set-back lines, rights of way and mortgages, if any, of record.


\$160,000.00 of the above-recited purchase price was paid from a mortgage loan closed simultaneously herewith.

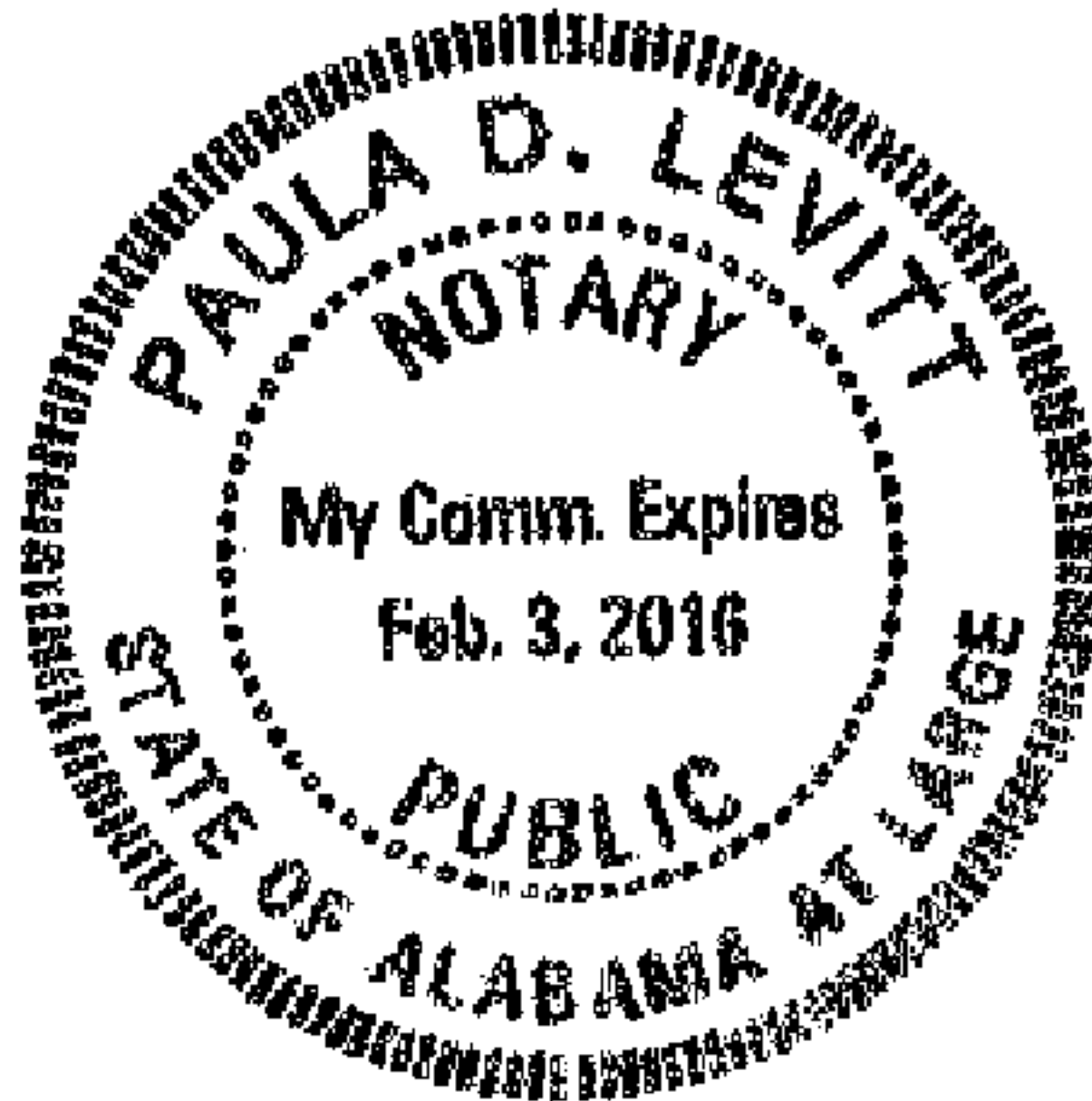
