**ARTICLES OF ORGANIZATION**  
**OF**  
**POINT OF REST, "L.L.C."**

I, the undersigned, desiring to form a Limited Liability Company pursuant to the laws of the State of Alabama, certify as follows:

1. The name of the Limited Liability Company is Point of Rest, "L.L.C."

2. The term of the Limited Liability Company shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama, and shall continue indefinitely, provided, however, that the Limited Liability Company shall terminate and dissolve (a) upon the death of the sole Member, or (b) termination by the Member in his sole discretion.

3. The purpose for which this Limited Liability Company is organized is:

To buy and sell and lease property and to otherwise transact any or all lawful business for which Limited Liability Companies may be organized under the Alabama Limited Liability Company Act.
