

CERTIFICATE OF FORMATION



Rock Ministry of Shelby County, Alabama Inc.

OF

A NONPROFIT CORPORATION

This certificate of formation is signed and acknowledged by the incorporator(s) for the purpose of forming a nonprofit corporation under the provisions of the Code of Alabama 1975, known as the Alabama Nonprofit Corporation Act and to comply with 501 (c)of the Internal Revenue Code as follows:

ARTICLE I

Name

The name of the corporation shall be the Rock Ministry of Shelby County,

Alabama Inc. and the corporation shall be authorized to trade in said name or to use any
other trade name not now being used by any other person, firm, or corporation.

ARTICLE II

Purpose

The objects or purposes of this Corporation are as follows:

- (a) To foster, develop and promote educational and religious and charitable causes in Shelby County, Alabama and throughout the state of Alabama.
- (b) To do all things necessary and incident to promote the general social, benevolent and charitable works of the

Corporation.

(c) To qualify under the Internal Revenue Code (I.R.C.) § 501

(c) by performing activities that are exclusively for the following: religious, charitable, literary, or educational purposes, and no part of the net earnings of which inures to the benefit of any private shareholder or individual, no substantial part of the activities of which is carrying on propaganda, or otherwise attempting, to influence legislation (except as otherwise allowed under Internal Revenue Code Section 501(h) and other applicable law) and which does not participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of (or in opposition to) any candidate for public office.

ARTICLE III

Powers

- (1) The Corporation shall have all the general powers enumerated in the Code of Alabama, 1975, sec. 10-3A-1 et seq.
- (2) To receive and administer funds for the aforesaid purposes, and for no other purpose, and to that end to take and hold by contract, agreement, bequest, devise, gift, purchase, lease, either absolutely or in trust for such objects and purposes or trust and by membership fees received and contracts entered into for its purposes as herein stated and for no other purpose.

ARTICLE V

Membership

The membership shall be open to all persons or organizations interested in furthering the aims of the corporation. Only patrons shall be entitled to vote at meetings of the members.

ARTICLE VI




