## CERTIFICATE OF FORMATION OF MOBILE FACILITIES, LLC

The undersigned, acting as the organizer, desiring to form a limited liability company in the State of Alabama, does hereby adopt this Certificate of Formation in accordance with the laws applicable to limited liability companies organized in Alabama, as may be amended from time to time:

- 1. The name of the Limited Liability Company is MOBILE FACILITIES, LLC, hereinafter referred to as the "Company".
- 2. The term of the Limited Liability Company shall commence on the date of the filing of this Certificate of Formation in the Office of the Judge of Probate of SHELBY County, Alabama, and shall continue indefinitely, provided, however, that the Limited Liability Company shall terminate and dissolve upon the first of the following events: (a) when there is no remaining Member, unless the holders of all the financial rights in the Limited Liability Company agree in writing, within 90 days after the cessation of membership of the last member, to continue the legal existence and business of the Limited Liability Company and to appoint one or more new members; or (b) on the written consent by all of the Members in their sole discretion.
  - 3. The purpose for which this Limited Liability Company is formed is:

To purchase, own, rent, and/or sell industrial facilities or real property, and to transact any or all other lawful business for which Limited Liability Companies may be formed under the laws applicable to limited liability companies formed in the State of Alabama, as may be amended from time to time.

- 4. The location and mailing address of the initial registered office shall be 112 Highland Park Drive, Birmingham, AL 35242, and the name of the initial registered agent at that address shall be Tiffanie L. Jones.


