KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of One Hundred Fifty-Seven Thousand Five Hundred And No/100 Dollars (\$157,500.00) paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Gregory G. Embry, an unmarried man (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Hubert James Little, III and Yvonne Harris- Little (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

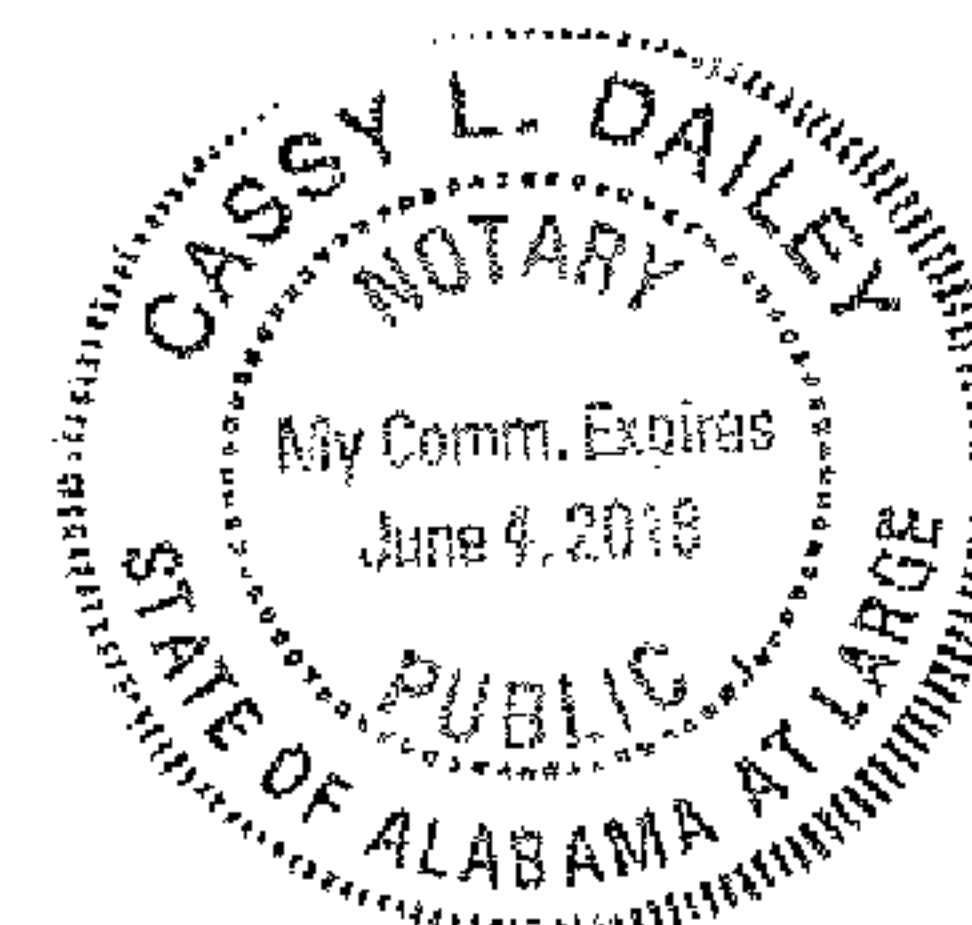

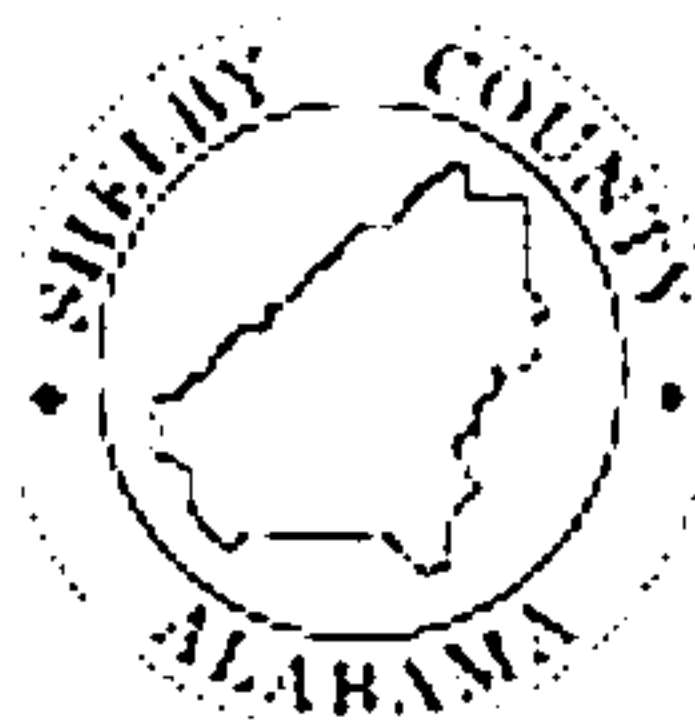
