Leah Anne Wood, formerly known as Leah Ann Lowe, and husband Roy Randall Wood [hereinafter known as Grantor(s)], for and in consideration of the sum of Five Hundred and NO/100 Dollars (\$500.00) to Them in hand paid by Alabama Power Company, a corporation, (hereinafter known as Grantee), the receipt whereof is acknowledged, do hereby grant to said Alabama Power Company, its successors and assigns, the right to construct, operate and maintain electric transmission and communication lines and all towers, poles, conduits, conductors, cables, insulators, anchors, guy wires, counterpoise conductors, and all other appliances necessary or convenient in connection therewith from time to time over, under and across, a strip of land 15 feet in width, as said strip is now located by the final location survey thereof heretofore made by said Company, over, under and across the lands of which it is hereinafter described as being a part, together with all the rights and privileges necessary or convenient for the full enjoyment or use thereof for the purposes above described, including the right of ingress and egress to and from said strip and the right to cut, remove, or otherwise kill, and keep clear by any means, including chemicals, all trees and undergrowth and all other obstructions under, on or above said strip and the right to cut such timber outside of said strip which in falling would come within five (5) feet of any conductor on said strip, and the right to install, maintain and use anchors and guy wires on land adjacent to said strip, and the right to install grounding devices on grantors' fences now or hereafter located on such strip and on fences or other structures of grantors now or hereafter located adjacent to such strip, and the right to prevent the use of such strip as a parking area for automobiles or other vehicles, as a storage area for machinery or materials, or as a road other than a road crossing such strip at a location which does not endanger or interfere with works that have been or may at some future date be constructed on such strip, said strip and the lands of which the same is a part being described as follows:

A strip of land, 15 feet in width, which lies within the Northeast Quarter of the Northwest Quarter (NE ¼ of the NW ¼) of Section 25, Township 18 South, Range 02 East, Shelby County, Alabama, such strip being more particularly described as follows:

To reach the point of beginning of said strip, commence at the Southeast corner of Section 26, Township 18 South, Range 02 East, marked by a found 2" open pipe; thence run N17°43'53"E, a distance of 5425.23 feet to a point, such point being the Point of Beginning of a survey line used to describe said strip of right-of-way herein described; therefrom said strip is 15 feet in width and lies to the right of said survey line (Less and Excepting any portion of said right-of-way which lies within an existing one hundred (100) foot road right-of-way of U.S. Highway #231), and the continuations thereof, which begins at such Point of Beginning and runs N37°18'21"E, a distance of 143 feet, more or less, to a point, such point being the point of ending of the strip of right-of-way herein described.


