

### MEMORANDUM OF LEASE

This Memorandum of Lease, dated the quantum day of November, 2015, is by and between FCPT HOSPITALITY PROPERTIES, LLC, a Delaware limited liability company, whose address is c/o: Four Corners Property Trust, Inc., 591 Redwood Highway, Suite 1150, Mill Valley, CA 94941 ("Lessor"), and RARE HOSPITALITY INTERNATIONAL, INC., a Georgia corporation, whose address is c/o: Darden Restaurants, Inc., Attn: Property Law Administration Dept., 1000 Darden Center Drive, Orlando, FL 32837 ("Lessee").

#### RECITALS:

On <u>Movember 9</u>, 2015, Lessor and Lessee entered into a written lease agreement (the "*Lease*") for certain property situated in the City of Hoover, Shelby County, Alabama, as more particularly set forth in the Lease and described on **Exhibit A** attached hereto (the "*Property*"), including any rights, rights of way, easements, water rights, and Lessor's right, title and interest in and to all streets, alleys, strips and gores abutting such property, if any; and

The parties desire to place their interests in the Lease as a matter of record.

NOW, THEREFORE, the parties represent as follows:

- 1. <u>Term.</u> The Initial Term of the Lease will be twelve (12) years and shall expire at midnight on October 31, 2027, unless terminated sooner as provided in the Lease and as may be extended as provided therein.
- 2. <u>Extensions</u>. Lessee has the right and option to extend the Initial Term for five (5) additional successive periods of five (5) years each, pursuant to the terms and conditions of the Lease.
- 3. <u>Right of First Offer.</u> The Lease contains a right of first offer to purchase the Property or interests therein, as more particularly described in Article 16 of the Lease.

Unless otherwise set forth herein, all capitalized terms used herein shall have the same meaning as set forth in the Lease.
