Vu H Nguyen

(herein referred to as GRANTEE, whether one or more), the following described real estate situated in **SHELBY** County, Alabama, to-wit:

Lot 7, according to the Survey of Cottages at Chesser, Phase I, recorded in Map Book 33, page 45, in the Office of the Judge of Probate Shelby County, Alabama.

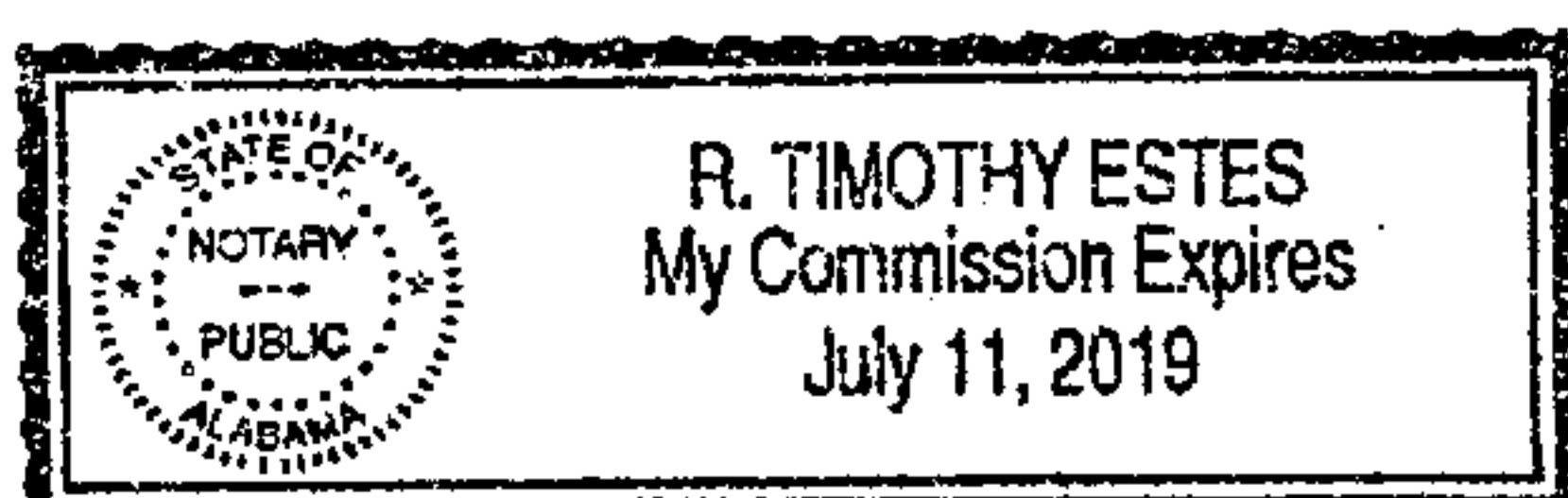

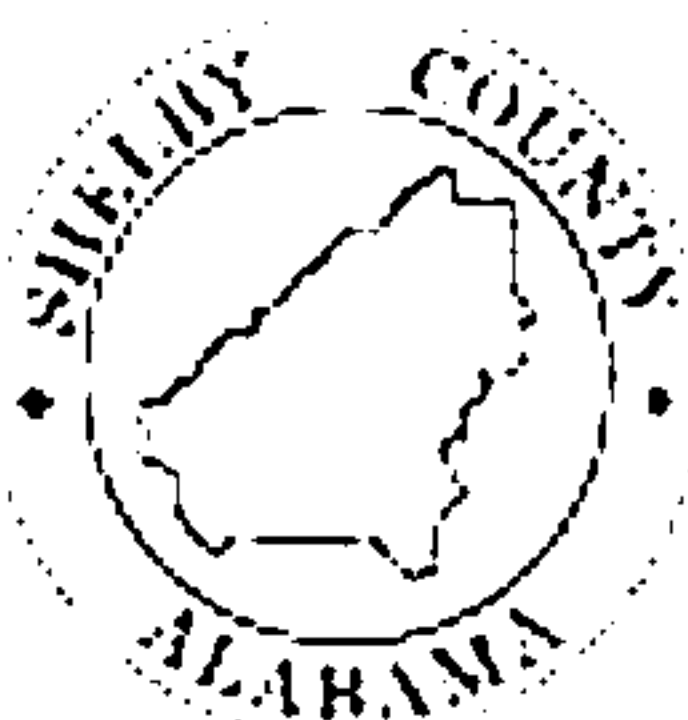
