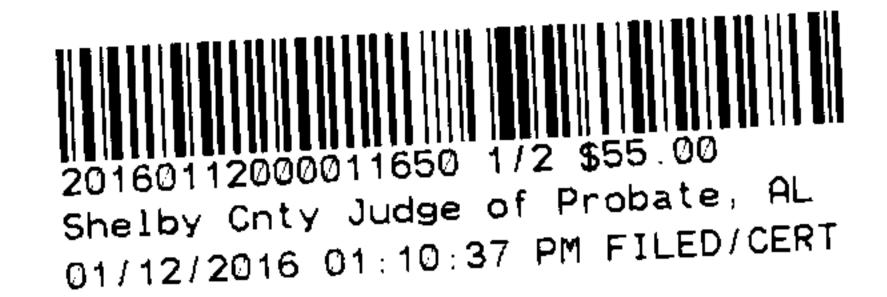
WARRANTY DEED

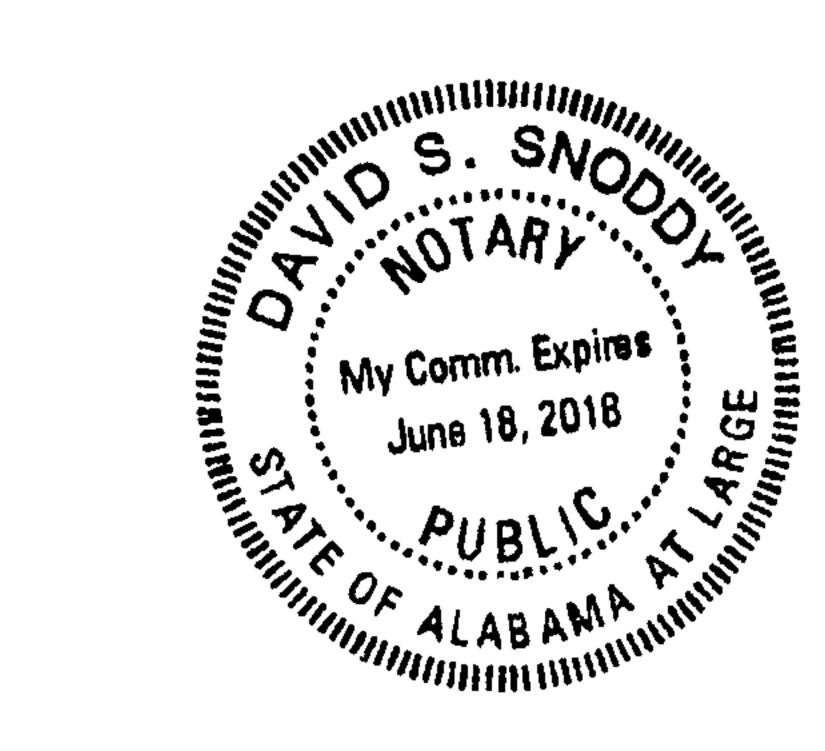

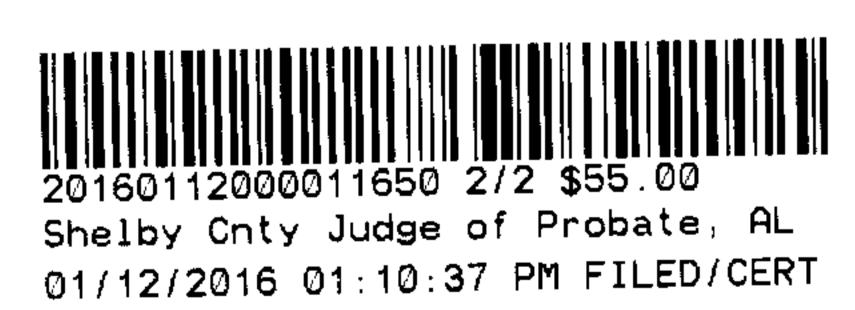
