That in consideration of the sum of One Hundred Twenty Five Thousand Dollars and No Cents (\$125,000.00), the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Thomas J. Devany, Jr. and Loraine M. Devany**, Husband and wife (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Terry D. Taylor and Deborah Taylor**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit:

Lot 1, according to the survey of Devany's Lakewood Estates, as recorded in Map Book 43, Page 110, in the Probate Office of Shelby County, Alabama.

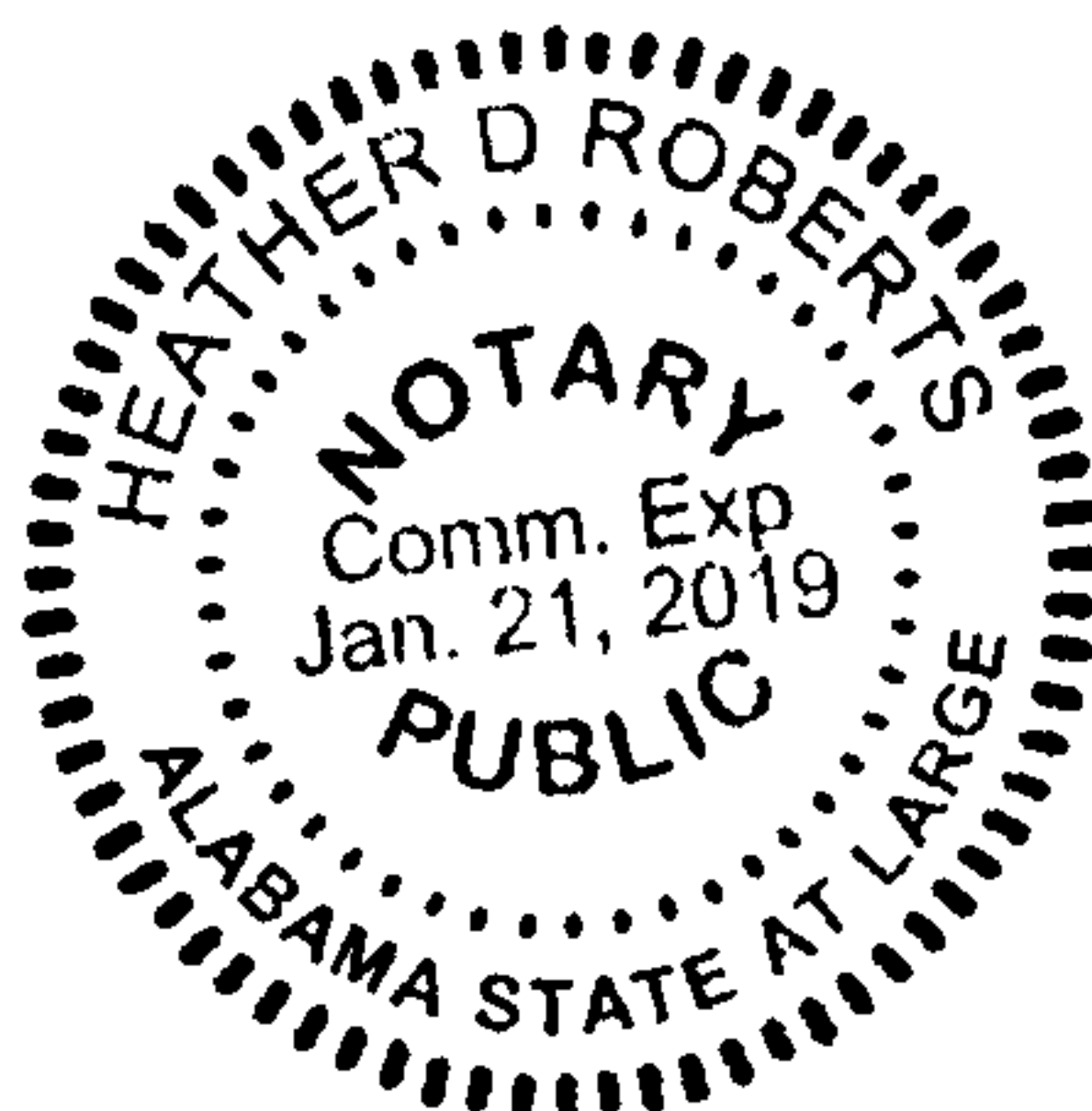
