Hutto and JoAnne Hutto**, Husband and wife (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Sam K. Williams and Mary H. 


\$178,750.00 of the purchase price of the above described property was financed with the proceeds of a mortgage loan closed simultaneously herewith.



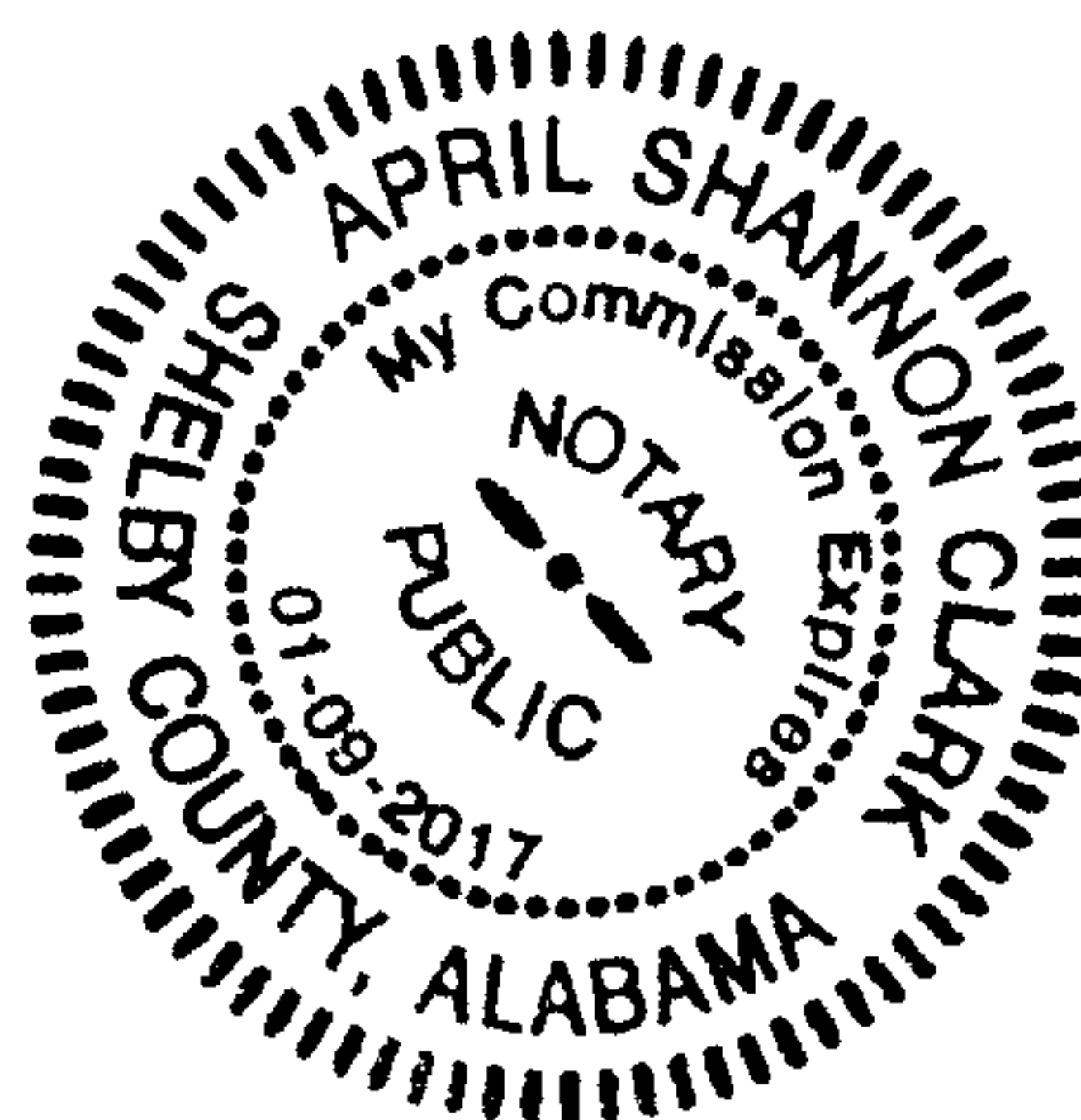
