

I, WILSIE THOMPSON HAYES, a citizen of the United States of America, a resident of the County of Jefferson, State of Alabama, being of sound and disposing mind and memory, do make, publish and declare this instrument as and for my Last Will and Testament, hereby revoking any and all other wills and codicils heretofore made by me.

#### ITEM I


#### **INTRODUCTION**

names are Clinton Douglass Hayes, Susan Hayes Snell and Gregory Thomas Hayes. For the purposes of this Will, references to my "children" shall mean the children named herein. As used in my Will, the terms "descendants" and "lineal descendants" are intended to include my children and any persons born to or adopted by my children or by any descendant of mine. Notwithstanding anything to the contrary herein, any person who is adopted on or after the age of twenty-one (21) years, and the lineal descendants of such adopted persons, are intended to be excluded from any reference herein to my descendants and lineal descendants.

#### ITEM II

#### PAYMENT OF DEBTS/PROBATE OF WILL

My Personal Representative shall first pay out of my estate all of my debts and expenses of administration, including the expenses of my last illness and funeral, as soon as possible after my death. I further direct that my Personal Representative may probate my Last Will and Testament either in

the county of my residence at the time of my death or in any county in the State of Alabama in which I may own property at the time of my death.

#### ITEM III

#### **DISPOSITION OF PERSONAL EFFECTS**

- desires with regard to the disposition of special personal property of mine. If I prepare such memorandum, it will be an expression of my desires with regard to the disposition of such personal property. Although I realize that such memorandum shall not be binding upon the Personal Representative, I hope and expect that the Personal Representative and my beneficiaries will honor this expression of my desires.
- (b) I give and devise my solitary diamond ring to my granddaughter, Anna Lauren Snell, if she should survive me. If my said granddaughter should not survive me, then this devise shall lapse, and said property shall become a part of my residuary estate.
- (c) I give and devise my cocktail ring with diamonds to my granddaughter, Valerie Marie Hayes, if she should survive me. If my said granddaughter should not survive me, then this devise shall lapse, and said property shall become a part of my residuary estate.
- provided in paragraphs (b) and (c) hereinabove of this Item), books, pictures, household furniture and furnishings, both useful and ornamental, any equity ownership interest in any club or organization of which I am a member, and all other objects of my personal use (except for any vehicle that I may own, which I intend to pass as part of the residue of my estate) and any cemetery plots, to my daughter, Susan Hayes Snell. If my said daughter should predecease me, then this devise shall lapse, and the aforesaid property shall become a part of the residue of my estate. I hereby vest in my said Personal Representative, hereinafter named, full power and authority to determine what objects of property are included in the foregoing description contained in this Item of my Will, and in the event my said daughter

shall not survive me, to make such division of said objects of property among my descendants as, in the opinion of my Personal Representative, may be desirable, having due regard for the personal preferences of my descendants.

#### ITEM IV

#### MONETARY DEVISES

- and 00/100 Dollars (\$10,000.00). I direct that this devise shall bear no interest from the date of my death or any date to the date of payment. If Samuel Gene Snell shall not survive me, then this devise shall lapse, and said property shall become a part of my residuary estate.
- (b) I give and devise to my grandson, Thomas Joseph Hayes, the sum of Ten Thousand and 00/100 Dollars (\$10,000.00). I direct that this devise shall bear no interest from the date of my death or any date to the date of payment. If Thomas Joseph Hayes shall not survive me, then this devise shall lapse, and said property shall become a part of my residuary estate.

#### ITEM V

#### DISPOSITION OF RESIDUE

All the rest, residue and remainder of the property which I may own at the time of my death, whether real, personal and mixed, tangible (including any vehicle I may own) and intangible, of whatsoever nature and wheresoever situated, including all property which I may acquire or become entitled to after the execution of this Will, including all lapsed legacies and devises and including any property over or concerning which I may have any power of appointment, I devise in fee and in equal shares to my children, Clinton Douglass Hayes, Susan Hayes Snell and Gregory Thomas Hayes. If any of my children should predecease me, then I give and devise said child's share of said property to his or her lineal descendants who survive me, if any, per stirpes, and if none, to such of my other children, and the lineal descendants of any other deceased child of mine, who survive me, per stirpes. If there shall be no

such child or lineal descendant of a deceased child who survives me, then such property shall pass to such person or persons as would be entitled to inherit the property constituting said share, and in the proportions in which they would be entitled to inherit the same, from me under the laws of Alabama then in force had I died at said time a resident of Alabama intestate and owned said property.

#### ITEM VI

#### DIRECTIONS REGARDING BENEFICIARIES

#### UNDER THE AGE OF TWENTY-FIVE OR WITH A DISABILITY

Except as otherwise provided in paragraph (b) below, if any of my beneficiaries (a) shall be under the age of twenty-five (25) years at my death, then I direct that my Personal Representative, in its sole discretion, shall either: (1) transfer and pay over the share of such beneficiary to itself, as Trustee, to hold such property in trust for said beneficiary until he or she shall attain the age of twenty-five (25) years, using and applying for such beneficiary's support, education and comfort, such part of the net income or principal, or both, from his or her share of the trust as the Trustee deems necessary or desirable for said purpose, with any income not so paid or applied to be accumulated and added to the principal of his or her share of the trust estate at the end of each fiscal year of the trust; or (2) if the Personal Representative determines that the beneficiary is able to handle all of his or her share at age twenty-one (21) years, then pay over said property to such beneficiary if he or she has attained such age, but if not, pay over said property to any custodial account that has already been established for the beneficiary, or if none exists, to a custodian designated by the Personal Representative from those persons, including the Personal Representative, who are eligible to serve as such custodian of the beneficiary under the Uniform Transfers (or Gifts) to Minors Act in effect in the state of the beneficiary's residence, for the use and benefit of the beneficiary. In all events, the share of any such beneficiary shall be deemed then to have vested in him or her, and shall be payable to his or her estate in the event of his or her death prior to attaining the age of twenty-five (25) years. If the trust option is chosen, I hereby vest in my Personal Representative as Trustee the same full powers of management and control over the

principal of said trust and accumulated income, if any, herein given to the Personal Representative over my estate under any paragraph hereof, and I direct that said Trustee shall not be required to give any bond or security for the performance of its duties as such Trustee. Upon making any such payment hereunder, the Personal Representative shall be discharged as to any sums so paid.

- Where I have herein directed that funds shall be used and applied by the Personal (b) Representative for the benefit of or paid to any beneficiary with a disability, regardless of age, who is receiving public assistance benefits because of such disability at the time of distribution, or, in the discretion of the Personal Representative, will likely become eligible in the future for public assistance benefits, then, instead of any other provision herein for the distribution of such beneficiary's share, the terms of this paragraph (b) shall control. The Personal Representative shall pay over such beneficiary's share to the Trustee of an existing third-party special needs trust for the benefit of such beneficiary, or shall establish a third-party special needs trust for such beneficiary to receive such share (including without limitation a private trust or a pooled trust account such as the Alabama Family Trust). The special needs trust selected by my Personal Representative to receive such share (whether then existing or established by my Personal Representative as a private trust or an Alabama Family Trust or other pooled trust) must be established for the benefit of such beneficiary, with income and principal to be applied for such beneficiary during his or her lifetime, in the complete discretion of the Trustee taking into account other resources and public assistance benefits available to such beneficiary, with any remaining funds in such trust or pooled trust account upon such beneficiary's death to be distributed in the same manner and to such beneficiaries as would have received such beneficiary's share hereunder if he or she had predeceased me.
- (c) The Personal Representative shall make such distribution decisions under this Item in its sole discretion. The receipt of the distributee under any of these methods of distribution shall be full discharge to the Personal Representative serving hereunder as to any sums so paid.

#### PERSONAL REPRESENTATIVES

- (a) I hereby nominate and appoint Susan Hayes Snell as Personal Representative of this, my Last Will and Testament. In the event Susan Hayes Snell shall predecease me or shall die during the administration of my estate or be unable or unwilling to serve as Personal Representative, then I nominate and appoint Ronald R. Snell to serve as Personal Representative.
- It is my will and desire that my Personal Representative, regardless of who shall (b) so serve, shall not be required to give any bond or security for the performance of its duties as such Personal Representative or to account to any court for its acts and doings as such Personal Representative, and that it is hereby expressly exempted from filing any inventory or making any report or final settlement of my estate. Said Personal Representative shall have full power, without the necessity for any order from any court, to sell (for payment of debts and all other purposes), exchange, lease, or encumber all or any portion of my estate in such manner and upon such terms and conditions as it may approve; to invest and reinvest my estate and the proceeds of sale of any portion thereof in such loans, stocks, bonds or other securities, mortgages, common trust funds, or other property as it may consider suitable, whether or not a so-called "legal" investment of trust funds, and to change investments and to make new investments from time to time as to it may seem necessary or desirable; to make divisions and distributions hereunder provided for either in cash or in kind or partly in cash and partly in kind, and for that purpose to determine the values thereof, and to determine the identity of persons entitled to take hereunder; to institute and defend any and all suits or legal proceedings relating to my estate, in any court, and to employ counsel and to compromise or submit to arbitration all matters of dispute in which my estate may be involved, as in its judgment may be necessary or proper. Said Personal Representative shall also have full power and authority, without the necessity for any order from any court, to pay the expenses of administering my estate, including the payment of compensation to my Personal Representative, at such time or times as my Personal Representative deems appropriate. Said Personal Representative shall also have full power and authority to continue to operate, carry on, repair, renew,

insure, and otherwise conserve and maintain any business or business item or asset of my estate, and to enter into and perform any contracts necessary and desirable in connection therewith, and shall have full power and authority to borrow money on account of my estate and secure same by mortgage or pledge of any asset thereof, all without the necessity for any other order from any court or notice to anyone whatsoever.
