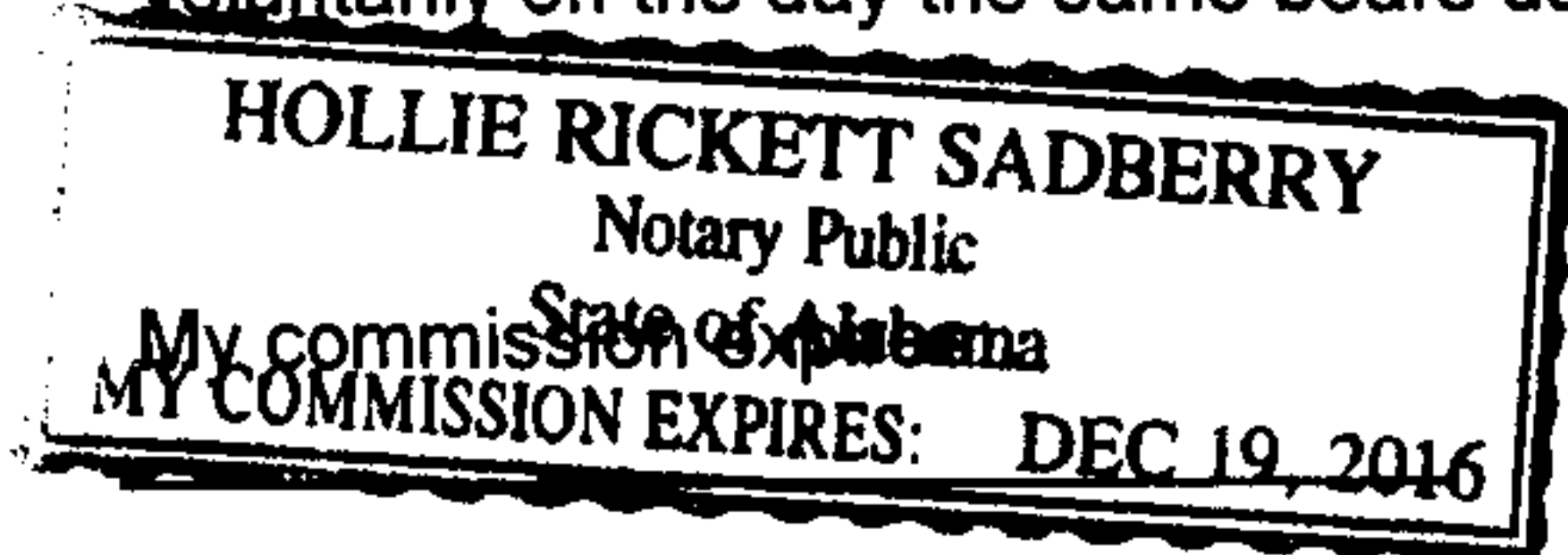

Parcel I

Part of the Southwest $\frac{1}{4}$ of Section 29, Township 19 South, Range 4 West, Jefferson County, Alabama, being more particularly described as follows: Commence at the Northwest corner of the Southwest $\frac{1}{4}$ of Section 29, and run in an Easterly direction along the North line of said $\frac{1}{4}$ section for a distance of 280.89 feet to an existing iron rebar; thence turn an angle to the right of 125 degrees 07 minutes 47 seconds and run in a Southwesterly direction for a distance of 97.21 feet to an existing #5 iron rebar; thence turn an angle to the right of 1 degree 02 minutes 56 seconds and run in a Southwesterly direction for a distance of 375.84 feet to an existing #5 iron rebar; thence turn an angle to the left 93 degrees 17 minutes 31 seconds and run in a Southeasterly direction for a distance of 1179.93 feet, more or less, to an existing iron rebar set by landmark and being the point of beginning; thence continue in a Southeasterly direction along the last mentioned course for a distance of 140.18 feet to an existing iron rebar; thence turn an angle to the left 96 degrees 24 minutes 13 seconds and run in a Northeasterly direction for a distance of 378.51 feet to an existing iron rebar set by Weygand; thence turn an angle to the left 83 degrees 40 minutes 33 seconds and run in a northwesterly direction for a distance of 98.26 feet to an existing iron rebar set by Weygand; thence turn an angle to the left of 90 degrees 00 minutes 26 seconds and run in a Southwesterly direction for a distance of 376.01 feet, more or less, to the point of beginning.
