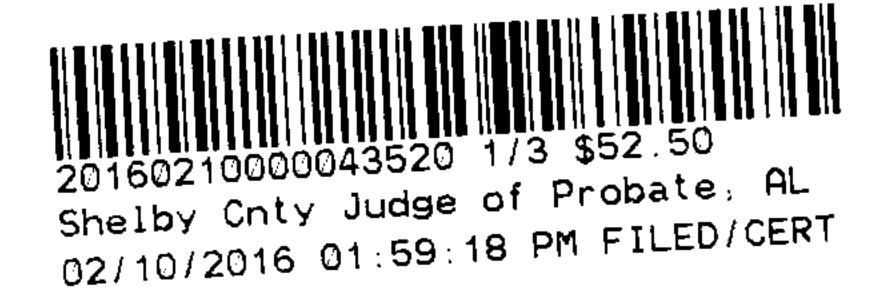

## **OUITCLAIM DEED**
