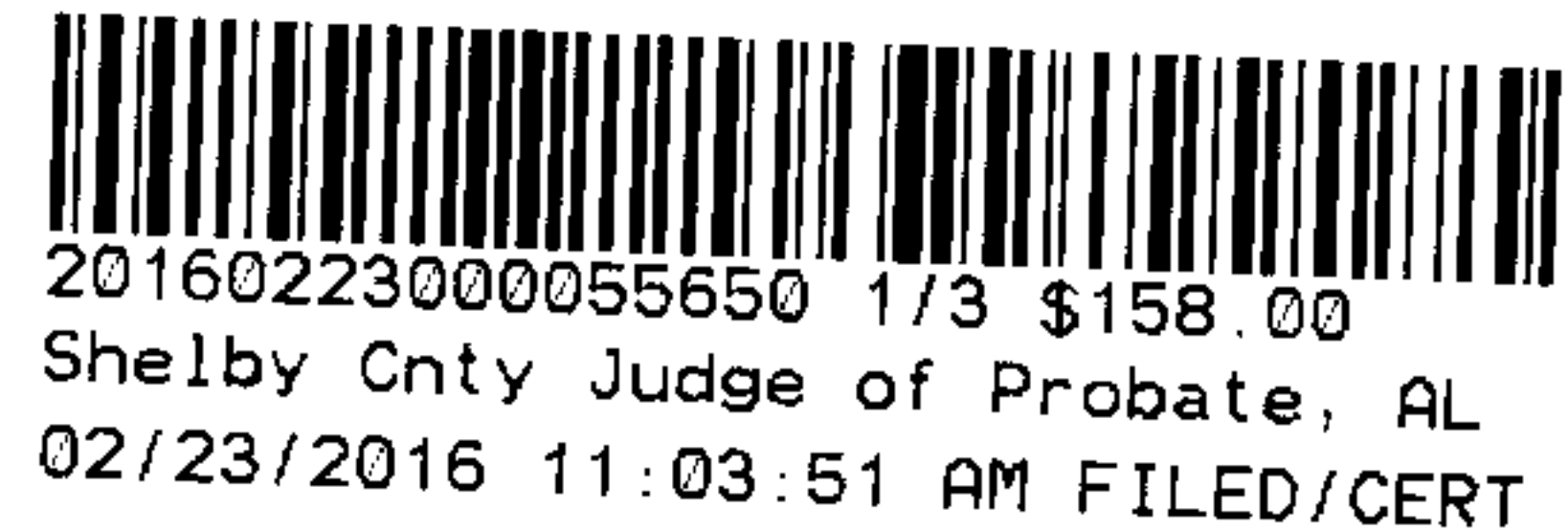

CERTIFICATE OF FORMATION

TO THE HONORABLE JUDGE OF PROBATE

The undersigned, for the purpose of forming a limited liability company pursuant to the provisions of the Alabama Limited Liability Company Law of 2014, CODE OF ALABAMA § 10A-5A-1.01 *et seq.* (the “Act”), files this Certificate of Formation (“Certificate”).

1. NAME. The name of the entity being organized and formed pursuant to this Certificate (the “Company”) is:

2. TYPE OF ENTITY. The Company is an Alabama limited liability company.

3. PURPOSES. The Company is being organized to transact any other lawful business for which a limited liability company may be formed under the Act.



6. MEMBERS. There is at least one member of the Company. Additional members may be admitted to the Company only in accordance with the provisions of the Act and any limited liability company agreement of the Company as such limited liability company agreement may be amended from time to time.

7. INDEMNIFICATION. The Company may indemnify and hold harmless, pay in advance or reimburse expenses incurred by, and purchase and maintain insurance on behalf of, its members, and if any, its managers, officers, agents and employees to the maximum extent permitted by applicable law.

8. AMENDMENT. The Company may amend, alter, change or repeal any provision in this Certificate in the manner now or subsequently provided by law and any limited liability company agreement of the Company (as such limited liability company agreement may be amended from time to time), and all rights conferred in this Certificate upon holders of membership interests are granted subject to this reservation; provided, however, no such amendment, alteration, change or repeal will be effective without approval of the members of the Company pursuant to the provisions of the Act or any limited liability company agreement in effect on the date of any such amendment.
