KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 23rd day of February, 2007, Thomas C. Johnson and Barbara C. 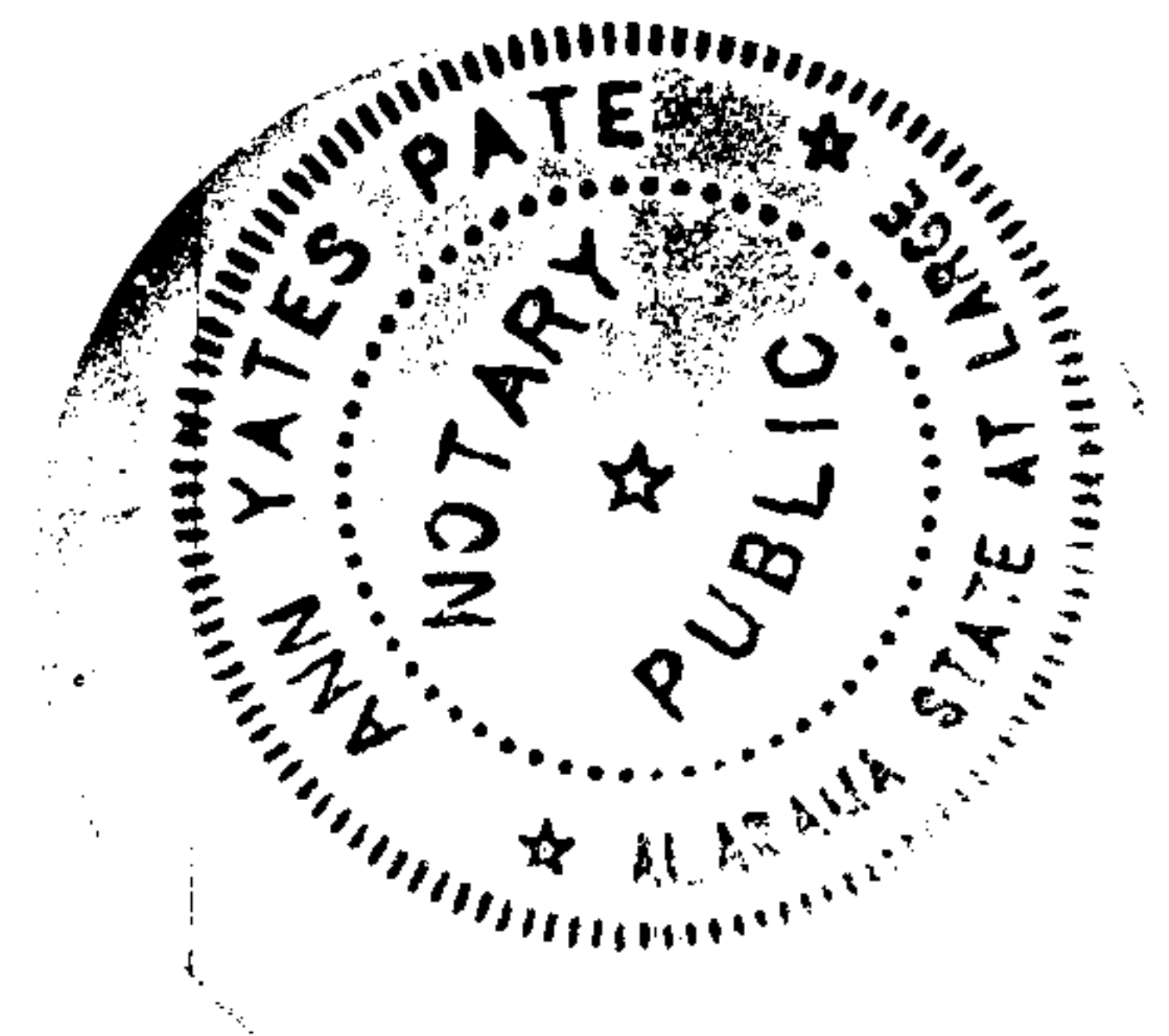
